COMMISSIONERS' ORAL COMMUNICATIONS / PARK REPORTS

Commissioner J. Johnson communicated that the window at Anderson Park was replaced however the big pieces of concrete around the uprooted tree still poses a safety hazard.

Commissioner K. Hilliard shared her anticipation of the Mills Park improvements.

Commissioner O. Ramos met with Foisia Park Supervisor J. Noa two (2) weeks ago regarding harmless insects that are a nuisance in the common areas next to the snack bar and in the office as well as an irrigation problem. The irrigation issue has been repaired and job has been completed

Commissioner C. Dahilig has visited Dolphin Park on two (2) successive dates and has noticed that the lights were being replaced. However he noticed there are leaves falling on the tennis courts which hampers ability to play. The trees are very tall and the branches and leaves cover some of the park lights as well.

Commissioner C. Dunning has made a couple of visits to Del Amo Park in the past month and was made aware by staff they spotted coyotes at the northeast end of the softball/baseball diamond. There is still a wait for the goals to be installed at the basketball courts

Secretary K. Cortado reported on Calas and Dominguez Parks. She stated that the baseball diamond at Calas Park is being worked on however the issue now is that the clay is very hard. Secretary K. Cortado asked if there is a time limit for tennis play at the parks. She also asked if something can be done regarding the frequent urination and odor at the corner of the stairwell going to the basketball court at Veterans Park.

Vice-Chair A. Cainglet thanked staff and elected officials for the Larry Itliong Day event. Asked that items be agendized for the next commission meeting in January regarding fee structure for the parks as well as Adult Sports.

STAFF ORAL COMMUNICATIONS

Director R. Lennox shared information on the upcoming Halloween Drive-Thru event at the Community Center East Parking Lot.

Recreation Superintendent T. Grierson communicated that there are rules posted at all tennis courts. If there are issues with players during times the park is staffed, everyone is welcome to notify staff of matters that need enforcement. Recreation Superintendent T. Grierson addressed the issues with the trees at Foisia Park. The tree over the tennis court has been trimmed and staff is looking into a repellent that can be placed on the trees to keep the insects away.

Director R. Lennox added that the Community Services staff has been putting in an immense amount of hours working at the call center for the Dominguez Channel odor issue as well as managing their own workload. He appreciates staff for all their hard work and dedication.
