Capital Projects

Using restricted monies allocated from other governmental agencies, and remaining amounts from redevelopment revenue; the City was able to budget capital projects totaling \$43 million in FY15-16.








General Fund Revenues

Challenges for the Future

The City faces numerous financial challenges. The utility user tax generates about 12% of the City's General Fund budget, and sunsets in June 2016. Voters will be asked to renew the tax on June 7, 2016, with no changes. The 2% tax applies to gas and electric only, and is one of the lowest rates in the County. This revenue pays for vital services, including public safety.

Recovery following the 2008 recession has been slow. Property values increased an average of about 0.5% per year since 2008. Neighboring South Bay cities have seen average annual increases of 1.5% to 2.1% over the same period.

Fuel taxes allocated to the City have been declining, and less money is available to repair the City's streets.

The employee pension and other retirement benefit plans have unfunded liabilities totaling more than \$78 million (104% of the annual General Fund budget). The City's costs to fund pension and other employee benefits are expected to continue growing much faster than the cost of living.

Federal and state law requires the City to ensure only clean water runs into local watersheds. The City has no dedicated funding source, and is expected to spend millions of dollars to comply with the mandates.

When California redevelopment agencies were dissolved in 2012, the City lost its most significant source of money to repair City infrastructure such as streets and parks.

The City will have to make some tough choices, and develop a long-term strategy to address priorities for the future.

City Staff

The City has 327 full-time employees, with 257 providing service in Public Works, Community Development, Recreation, Public Safety and Human Services.

The City also employs about 400 part-time staff, primarily serving the City's Recreation and Human Services programs.

The salary & benefits budget totals \$38 million or 51% of General Fund.

The City of Carson only receives a tiny portion of your property tax, as shown below.
