Report Back From City Council

On behalf of the committee, I spoke at the last City Council meeting (15 May, 2018) to provide the City Council a status update of our committee meetings and to ask for direction/guidance since the initial scope provided by the City Council was vague. I also submitted the attached memorandum dated 15 May, 2018 to the City Council. Three (3) main directives were given by the City Council.

#### REORGANIZATION

At the 15 May, 2018 City Council meeting (item #21), the City Council reorganized the "Committee of the Proposed City Charter" from a 9-member, 3-alternative set-up to a 12-member, 0-alternatives and have replaced Alternate No. 2 - Cedell Bush with Lambert Adouki. The three (3) alternate members are now committee members.

#### REQUEST TO NARROW THE TOPICS FOR CONSIDERATION

Members of the committee have made it very clear during the past committee meetings that the number of topics to be considered in the charter is far more than we have time for and have requested for a narrow list of topics to focus our energy and time on. Members of the committee and the public also posed the question as to the rush of the charter process.

The only answer/direction I was given was that the City Council would like for the Committee to consider everything and to have as many meetings as we need. This leads me to the last directive – future meetings.

#### SCHEDULING OF FUTURE MEETINGS

The City Council has directed that we have meetings throughout June and July in order for us to prepare and review the proposed charter. The reason there's no charter for us to review is because the City Council has not given staff direction at the past two City Council meetings (1 May and 15 May, 2018) as for what contents should be considered in the charter.

The City Council acknowledged at the 15 May, 2018 City Council meeting that the topics for the charter is being left to the Committee to prepare and review. With that, we'll need to decide and schedule the upcoming Committee meetings.

#### **FUTURE CITY COUNCIL MEETINGS**

Considering the short time frame we are on, I had requested to City Manager Farfsing that the Committee have a standing staff report on the City Council agenda (excluding the public hearings) to give the Committee the opportunity to report back to the City Council and to give the City Council the ability/flexibility to give directives to the committee and staff on an on-going basis. My hope is that this will provide a more open process.

Status Update - Committee of the Proposed City Charter

As the appointed Chair of the Committee of the Proposed City Charter, I thought it would be best to provide the City Council a status update from the committee versus waiting to speak at the scheduled City Council Public Hearing to be held on 29 May, 2018 at 12:30 pm.

As of today, the 9-member Committee of the Proposed City Charter has held two (2) public meetings. The first meeting was held on 7 May, 2018 and the second on 14 May, 2018; both held at the Carson Community Center – Dominguez Room. The next scheduled committee meeting is set to occur on Monday, 21 May, 2018, 6 pm at the Carson Community Center – Dominguez Room.

At the 7 May, 2018 committee meeting, the members of the committee were introduced by City Manager Ken Farfsing and the election of the Chair, Vice Chair (Karen Avilla) and Secretary (Dr. Sharma Henderson) were made. Charter presentations and possible contents of a charter were presented by staff: City Manager Ken Farfsing, City Attorney Sunny Soltani, and Assistant City Attorney Lum Fobi.

In response to requests made by members of the public at the 7 May, 2018 meeting, I requested for staff to set-up a designated area on the City of Carson's website, dedicated to the potential charter. This portal has already been set-up and all documents supplied to the committee are now publicly accessible.

At the 14 May, 2018 committee meeting, contents of other City Charters (Cities of Torrance, Rancho Palos Verdes, and Inglewood) were presented by staff. As requested, staff also provided a timeline to the charter process.

It was also discussed at the 14 May, 2018 meeting about the possible topics that the committee may take into consideration for the possible charter.

Based on the comments from the public and discussions held by the committee from the past two meetings, the following topics were the main points identified:

- 1. Form of Government:
  - a. City Manager led versus Strong Mayor.
- 2. Mayor at-large versus direct elected.
- 3. City Council Districts.
- 4. Mayor and City Council compensation.
- 5. City Clerk and City Treasurer:
  - a. Appointed versus elected.
  - b. Compensation.
- 6. Why is there a sense of urgency to switch to a charter city from general law?

In preparation of the upcoming committee meeting on 21 May, 2018, I ask that the City Council give staff direction as to narrow down/prepare a listing of topics for the committee to take into consideration for the potential charter.
