Hello Lt. Williams,

Attached, please find the analysis that had been previously done for the 2018 Supplemental EIR. The mitigation measures assumed for the 2018 Supplemental EIR are also included in the attached word document. As part of the analysis for the 2021 Supplemental EIR we are working on, we want to confirm that these mitigation measures are still acceptable to address any potential impacts related to police protection, particularly as the uses on the Planning Area 3 are changing

under the 2021 Supplemental EIR to replace commercial uses, including hotel, restaurant, retail center, neighborhood serving retail, and entertainment uses to industrial, community service commercial, and park uses. As noted on the call earlier, all uses proposed under Planning Area 1 (1,250 units) and Planning Area 2 (711,500 regional commercial uses)

I have also included the proposed site plan that will be analyzed under the 2021 Supplemental EIR.
