This serves as the City of Carson's Notice of Intent to adopt a Mitigated Negative Declaration for the Victoria Greens project (proposed project), prepared in accordance with the California Environmental Quality Act (CEQA), CEQA Guidelines, and local implementation procedures.

Project Description: The proposed project involves the construction of a 175-unit multifamily residential community consisting of 95 three-story row townhome units and 80 three-story stacked flat units, a recreation center, a dog park, and a linear park contained in a secured, gated community. The approximately 8-acre project site would be comprised of approximately 23,665 square feet of recreational area.

> The project site was identified on a hazardous materials site, enumerated under Section 65962.5 of the Government Code, as a result of its historical use for oil exploration activities. As such, construction of the proposed project would comply with the Remedial Action Plan, as approved by the Regional Water Quality Control Board, to ensure excavation activities are performed in a manner that reduces risk of hazard to the public, future site occupants, workers, and/or the environment.

NOTICE IS HEREBY GIVEN THAT the City of Carson (City) proposes to adopt a Mitigated Negative Declaration for the above-referenced project. Such Mitigated Negative Declaration is based on the finding that, by implementing the identified mitigation measures, the project's potentially significant environmental effects will be reduced to levels that are less than significant. The reasons to support such a finding are documented by an Initial Study prepared by the City.
