1. INTERIOR LANDSCAPE TO BE MAINTAINED WITH PERMANENTLY INSTALLED IRRIGATION SYSTEM TO ALL PLANTING AREAS, CONSISTENT WITH CMC 9162.52 A.5  
2. ANY PLANT SPECIES WITH THE PRESENCE OF POTENTIALLY DANGEROUS THORNS SHALL BE LOCATED AWAY FROM PEDESTRIAN WALKWAYS AND VEHICULAR PARKING AREAS.  
3. TREES AT PAVED AREAS IN LANDSCAPED COURTYARD BETWEEN BUILDING A & B TO RECEIVE CU STRUCTURAL SOIL PER DETAIL A. ALL TREES TO BE LOCATED WITHIN PLANTING AREAS.  
4. LANDSCAPE AND ASSOCIATED HIGH EFFICIENCY IRRIGATION SYSTEM TO BE CONSISTENT WITH CMC 9168.1/TITLE 20.
