# CARSON CITYWIDE PAVEMENT UPGRADE



We are proud to announce an extensive Citywide Pavement Upgrade. The City of Carson will be repairing and resurfacing residential streets in all districts. The work will include grinding the roadway surface and paving a new asphalt layer.

The project is scheduled to start in March of this year. Construction work will be done during business hours, Monday through Friday from 7:00 a.m. – 5:00 p.m., except City of Carson observed holidays.

There will be “No Parking” signs posted throughout the project indicating the dates work will be performed in that area. During construction, access to through traffic may be delayed and we ask the following:

1. Please comply with all posted parking restrictions. Vehicles parked in posted “No Parking” areas may be subject to towing and will prolong the repaving process.
2. Trash pickup and street sweeping may be disrupted. Future notices will provide more up-to-date information.
3. For the safety of the children, please always keep them away from active project sites.

This work will cause some temporary inconveniences. We appreciate your assistance during this time as we work to improve the City of Carson.

# FAQS



## **1. How will I know that street maintenance is happening in my area?**

There will be “No Parking” signs posted throughout the project indicating the specific dates work will be performed in that area. The schedule and list of streets will be posted on the City’s website and social media accounts. Electronic message boards will be posted at strategic locations throughout construction. City contractors will work with the Public Information Office to make sure information is provided to the affected residents. You can also call (310) 847-3535 to request additional information.

## **2. Why are so many streets going to be under construction?**

The Public Works Department is working to address a backlog of deferred maintenance for the City’s streets. Council tasked Public Works to find an approach that systematically addresses as many streets as possible in the shortest amount of time.

## **3. How did you determine which streets were priority?**

The Pavement Condition Index (PCI) rated the condition of the streets in Carson. Staff identified the streets in each District that were rated as poor to kick off this project.

## **4. How long will this project be?**

This is considered as an ongoing maintenance project. The construction will be very busy and will require continuous scheduling. As the number of streets completed increases, construction will decrease.

## **5. What hours will construction take place?**

Monday through Friday from 7:00 a.m. till 5:00 p.m., except the City’s observed holidays, with rare exceptions.

## **6. Who’s paying for these street improvements?**

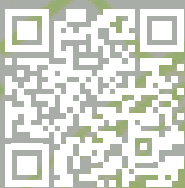
At the November 7, 2023, Regular Meeting of City Council, the Council approved funding for this project from the General Fund reserves account.

## What is Organic Waste?

Organic waste is defined as lawn and landscaping clippings, wood and lumber, food, food-soiled paper and other paper and cardboard products.



## What is SB1383?

In 2016, The California Senate Bill (SB)1383, was signed into law, which expands organic recycling requirements to all California properties including private residences starting January 1, 2022.



## What goes in the Organics/ Green Waste Bin?

- Food scraps
- Food soiled paper (i.e. used pizza boxes, used paper napkins /paper towels, paper bags, paper containers)
- Grass, leaves, yard waste, plants, branches
- Coffee grounds, coffee paper filters, tea bags
- Untreated wood and natural fibers (popsicle sticks, wooden chopsticks, toothpicks)



## 5 STEPS TO REDUCE YOUR FOOD WASTE

1. **PLAN AHEAD** - Make a grocery list for the meals you plan on making.
2. **BUY IN BULK** - This is often less expensive and you can buy only what you need to minimize waste! You can also take your own containers to skip the plastic.

3. **USE WHAT YOU HAVE** - Double check what you have at home and try to use it in your next meal!

4. **COMPOST** - Composting is the combining and managing of specific waste materials so that they decompose. Once the materials are mixed together, microbes in the soil will start to breakdown the waste and turn it into the nutrient rich materials that helps plants grow.

5. **EDUCATE** - Volunteer at a food bank or community compost to spread awareness and learn more about how to reduce food waste.

Trash & recycling containers are not allowed to be visible from public right-of-way except AFTER 6 P.M. the day before scheduled pick-up UNTIL 10 P.M. the day of pick-up. Smaller containers can be requested from Waste Resources (888) 467-7600.

Appliances, furniture, trash, & other items are not allowed to be visible from the public right-of-way. Large/bulky item pick-up can be requested through Waste Resources (888) 467-7600.
