**SUBJECT: CONSIDERATION OF RESOLUTION NO. 10-092 ORDERING THE TRANSFER OF UNCLAIMED FUNDS IN THE AMOUNT OF FIVE HUNDRED FORTY-TWO THOUSAND ONE HUNDRED NINE DOLLARS AND TWENTY-EGHT CENTS (\$542,109.28) TO THE GENERAL FUND OF THE CITY OF CARSON**

## **I. SUMMARY**

The City Treasurer has had in her possession, custody, or under her control for more than three (3) calendar years, certain unclaimed funds deposited into the Trust and Agency account of the City of Carson. These funds represent deposits for public works and/or planning requirements or bonds, rental facility deposits and stale-dated checks. Following the collaborative research with the department requiring the deposit and the finance department, these funds were deemed to be refundable but unclaimed.

Government Code § 50050 allows for the transfer of such funds to the City following due notification and publication. Said notification and publication has been concluded and it is now appropriate for the City Council to adopt the resolution transferring these funds to the General Fund of the City.

## **II. RECOMMENDATION**

WAIVE further reading and ADOPT Resolution No. 10-092, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, ORDERING THE TRANSFER OF UNCLAIMED FUNDS IN THE AMOUNT OF FIVE HUNDRED FORTY-TWO THOUSAND ONE HUNDRED NINE DOLLARS AND TWENTY-EGHT CENTS (\$542,109.28) TO THE GENERAL FUND OF THE CITY OF CARSON."

## **IV. BACKGROUND**

Government Code § 50050 allows for the transfer of unclaimed funds held by the Treasurer of a local agency for a period of over three (3) years following notification and publication. Said notification is described as publication of the Notice of Unclaimed Funds in a newspaper of general circulation for two successive weeks.

Pursuant to Government Code § 50051, the City caused to be published in two (2)

newspapers of general circulation, to wit: the Our Weekly newspaper and the Daily Breeze newspaper, notices of unclaimed funds on deposit with the City, instructing claimants of their right to file a claim for such funds, and advising that the City of Carson proposed that all unclaimed funds become the property of the City. The dates of such publication were July 1, 2010, and July 8, 2010, in the Our Weekly newspaper and July 1, 2010, in the Daily Breeze newspaper. A copy of the notice is attached as Exhibit No. 1.

The notice published in the newspaper advertised unclaimed funds in the amount of \$736,894.71. In response to the notice, eighteen (18) claims were filed for which a total of \$47,535.59 was refunded; fifteen (15) claims are pending completion of the claimant process representing \$28,741.59; and two (2) unclaimed funds posted in the amount of \$92,857.08 were posted in error and therefore removed from the proposed transfer. Additionally, after further research the Public Works Division has determined that \$25,651.17 of the unclaimed funds posted should have been transferred to the general fund for reimbursement of work performed rather than published on the unclaimed funds list and therefore, those funds have been removed from the proposed transfer. Please see Exhibit No. 2 for a detail of the funds removed from the proposed transfer.

Pursuant to Government Code § 50053, it is now appropriate for the City Council to adopt Resolution No. 10-092 approving the transfer of unclaimed funds which were published but remain unclaimed following the forty-five (45) day waiting period which expired August 16, 2010 (Exhibit No. 3 ).

**V. FISCAL IMPACT**

City Council's approval of this resolution will result in the transfer of \$542,109.28 from the Trust and Agency accounts to the General Fund as of June 30, 2010.

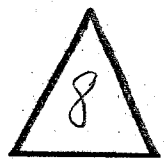

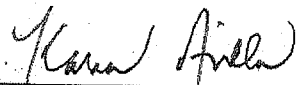

RESOLUTION NO. 10-092

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, ORDERING THE TRANSFER OF UNCLAIMED FUNDS IN THE AMOUNT OF FIVE HUNDRED FORTY-TWO THOUSAND ONE HUNDRED NINE DOLLARS AND TWENTY-EIGHT CENTS (\$542,109.28) TO THE GENERAL FUND OF THE CITY OF CARSON

The CITY COUNCIL of the CITY of CARSON, CALIFORNIA, does hereby FIND, DETERMINE, and ORDER as follows:

Section 1. The City Treasurer has had in her possession, custody, or under her control for more than three (3) calendar years, certain unclaimed funds deposited into the Trust and Agency account of the City of Carson. Pursuant to Government Code § 50050, such funds were eligible to become the property of the city of Carson following notice to potential unclaimed fund claimants and the expiration of a period of forty-five (45) calendar days within which to file a claim for such funds.

Section 2. Pursuant to Government Code § 50051, the City caused to be published in two (2) newspapers of general circulation, to wit: the Our Weekly newspaper and the Daily Breeze newspaper, notices of unclaimed funds on deposit with the City, instructing claimants of their right to file a claim for such funds, and advising that the city of Carson proposed that all unclaimed funds become the property of the City.
