

I. SUMMARY

The City of Carson Special Municipal Election with the General Election will be held on Tuesday, November 2, 2010, to submit to the qualified electors Measure H, The Carson Vital City Services Emergency Protection Measure.

On June 2, 1998, members of City Council requested that City Council and Redevelopment Agency meetings not be held on election days and has continued this "No meeting on Election Day" as an accepted practice.

IV. BACKGROUND

It has been the accepted policy of the Mayor/Chairman and City Council/Redevelopment Agency to reschedule Council and Agency regular meetings to another date to accommodate their absences due to their official attendance at conferences and seminars. In addition to this policy, the Mayor/Chairman and City Council/Redevelopment Agency have rescheduled meetings because of other special occasions and needs.

The policy now includes no scheduled regular meetings to be held on municipal and statewide election days or when the canvass, certification of election results and swearing-in of the newly elected Mayor, Council Members and including the City Clerk and City Treasurer, when on the ballot, takes place.

It has been the custom of the Mayor/Chairman and City Council/Redevelopment Agency to move the regular meetings to the following Wednesdays, in most instances.
