NEW BUSINESS (Item 1-2)

ITEM NO. (1) CONSIDERATION OF TRAFFIC AND PARKING ISSUES ON CITY STREETS NEAR CAROLDALE ELEMENTARY SCHOOL

ACTION:

Richard Garland gave a report to the committee on LAUSD parking arrangements. Mr. Garland inspected the signs surrounding the school. Currently, the red curbs are marked "No parking 7 a.m. to 4 p.m." which is a designated drop off zone. Mr. Garland suggested changing the parking restrictions to "Passenger loading only 6:30 a.m. – 9:00 a.m. and from 1:30 p.m. – 4:00 p.m. and 9:00 a.m. – 1:30 p.m. 2 hour parking"

Chairperson Dear made a motion to change the Carson parking restrictions surrounding all public schools in Carson

ITEM NO. (2) CONSIDERATION OF BUSINESS LICENSE FEES FOR BROKERS AND REALTORS

RECOMMENDATION for the City Council Sub-Committee:

1. DISCUSS and PROVIDE direction.

ACTION: Continued for 90 days. David Kissinger gave a presentation to the committee that other cities in the South Bay charge less money for real estate agents less fees to do business.

According to Mr. Kissinger, when you combine CA business professions code with the Federal Internal Revenue code the short of it is: Real Estate agents are considered contractors for personal income tax purposes; they are considered employees for business tax purposes. He asked that we survey other South Bay cities to see if brokers and agents are both responsible for a carrying business license. He compared Carson's municipal code to the likes of Redondo Beach and Lomita.

Mayor Dear made a motion to continue this item and bring it back within 90 days. Staff should prepare a matrix including information what other cities charge brokers vs. realtors. Committee member Santarina requested Mr. Kissinger bring back several cases with analysis to consider at the next meeting.



UNFINISHED BUSINESS (Item 3)

ITEM NO. (3) DISCUSSION OF CITY POLICY REGARDING PARKING ON CITY STREETS DURING STREET SWEEPING HOURS

RECOMMENDATION for the City Council Sub-Committee:

1. DISCUSS and PROVIDE direction.

ACTION: Continued and to be brought back in approximately 30 days.

The committee took public comment from Johnny Asheline and Johnny Cuico.

Chairman Dear made a motion that we change our policy in Carson to reflect that once the street sweeper has passed by we allow people to park the street without receiving a citation. Mr. Garland indicated to the committee that sign changes would not be necessary. Staff would need to notify parking enforcement of the new policy.

Mr. Cruz requested this item by continued to give Ken McKay an opportunity to address the sub-committee on this matter. The committee members agreed. Motion withdrawn.

Committee Member Santarina requested a staff report prior to the next sub-committee meeting that addresses all the issues associated with making this type of policy change. Mr. Cruz offered to prepare the staff report and submit it to Mr. Asheline and Mr. Cuico prior to the next meeting.
