SUBJECT: CONSIDERATION TO HOLD A 9/11 MEMORIAL TRIBUTE EVENT

I. SUMMARY

The Public Relations Commission (PRC) is proposing to hold a 9/11 Memorial Tribute to commemorate the 10th anniversary of 9/11. The tribute is proposed to take place on Sunday, September 11, 2011, at 7:00 p.m. in the atrium of the Congresswoman Juanita Millender-McDonald Community Center (Community Center).

II. RECOMMENDATION

- 1. AUTHORIZE the use of the Community Center and City resources to organize and publicize the 9/11 event.
- 2. AUTHORIZE staff to solicit donations for the event.

III. ALTERNATIVES

The City Council may TAKE any action it deems appropriate.

IV. <u>BACKGROUND</u>

On July 19, 2011, the PRC voted to hold a 9/11 Memorial Tribute to commemorate the 10th anniversary of the terroristic attacks that took place on September 11, 2001 (Exhibit No. 1). In the years following September 2001, the City of Carson and the PRC have jointly sponsored an annual 9/11 memorial tribute every September. However, due to budgetary cuts, the event was suspended beginning 2008.

This year, as the attack marks its 10th anniversary, the commission felt that it is appropriate to hold a small yet solemn recognition as a tribute to the historic event and the thousands of lives that were lost during the attacks. The event proposed by the commission will be held in the atrium of the Community Center, and will involve the participation of key speakers from the L.A. County Sheriff's and Fire Departments, Carson's faith community, and local choirs. It will also feature a special 9/11 video presentation and will conclude with a community candlelight vigil.

In previous 9/11 events, the main expenditures included light refreshments, the purchase of miniature US flags which served as giveaways, candles, and the

services of a bagpiper. This year, the commission directed staff to solicit donations for refreshments and candles, and forego the services of the bagpiper in the interest of reducing the cost of the event. It is also asking the City Council to authorize the use of the Community Center, other City resources, and the use of Community Center and Public Information Office (PIO) personnel to organize, publicize and staff the event.

V. FISCAL IMPACT

If the City Council approves the above recommendations, the City will incur indirect costs such as the use of the Community Center and other City resources such as postage and promotional materials, and use of staff time, including some overtime work for Community Center and PIO staff.

ACTION: Vice Chair Clayton made a motion to direct staff to move forward with coordinating the 10^{th} anniversary of 9-11 by contacting local businesses for possible sponsorship. The motion was seconded by Commissioner Robinson and carried with a vote of 7-0. During discussion, the commission also reached a consensus on the following issues:

- Submit the item for City Council approval at the August 2, 2011 Council meeting
- Both staff and members of the Public Relations Commission will contact businesses for possible sponsorship to raise funds for refreshments
- Contact speakers and participants from the L.A. Sheriff's and Fire Department, Carson's faith community, and local choirs
- Produce a special 9-11 video, to be handled by Commissioner Montinola, with assistance from Vice Chair Clayton and some footage to be provided by Commissioner Jones
- Not to hire the services of a bagpiper as a cost-saving measure
- Meet after the Council has approved the event in order to finalize the program
