Acting City Clerk Biggs reported that a letter of support dated February 28, 2012 addressed to the Mayor and Members of the City Council for the appointment of Donesia Gause as Interim City Clerk, was received from Larry Herrera, City Clerk, City of Long Beach. Copies of the letter were provided to the Mayor Pro Tem, Council Members, City Attorney, Acting City Clerk, and the City Treasurer.

Donesia Gause submitted an Overview of Qualifications for Donesia Gause, Applicant for Appointment of City Clerk, City of Carson, California dated February 28, 2011. Copies of the handout was provided to the Mayor Pro Tem, Council Members, City Attorney, Acting City Clerk, and the City Treasurer.

City Attorney Wynder stated that it would take three affirmative votes to select a City Clerk this evening and confirmed that all four candidates were domiciled and registered voters in the city of Carson.

#### **Administration of Oath**

City Attorney Wynder requested that all four candidates stand and take the Oath and that they were legally domiciled and registered to vote in the city of Carson.
