SUBJECT: CONSIDER THE FEE FOR THE EXTENDING WAIVER USE OF CONGRESSWOMAN JUANITA MILLENDER-MCDONALD COMMUNITY CENTER AT CARSON FOR ASOCIACION CULTURAL DE SOUTH BAY OF GREATER LOS ANGELES MARIACHI ACADEMY, **APOLLO** WEST PLAYERS, SOPHISTICATED DANCE

I. <u>SUMMARY</u>

This item is on the agenda at the request of Mayor Pro Tem Julie Ruiz-Raber.

On July 20, 2010 the City Council voted to waive fees for the use of the Congresswoman Juanita Millender-McDonald Community Center at Carson (Community Center) for eight community groups that previously received funding by the City Council through the City's Cultural Arts Commission (Exhibit No. 1). The fee waiver was provided in order to assist these groups with holding rehearsals and meetings and their fundraising efforts. The term of the fee waiver was for all of Fiscal Year 2010/11. Of the eight groups given this opportunity, three actually took advantage of the fee waivers – The Mariachi Academy of Carson, Apollo West Carson Players, and Sophisticated Dance. Tonight, the City Council is asked to provide direction to staff regarding whether to continue waiving the fees for the use of the Community Center for these three groups for Fiscal Year 2012/13.

II. RECOMMENDATION

PROVIDE direction to staff regarding whether to continue the fee waiver for the use of the Congresswoman Juanita Millender-McDonald Community Center at Carson for the Mariachi Academy of Carson, Apollo West Players, and Sophisticated Dance for Fiscal Year 2012/13.

III. <u>ALTERNATIVES</u>

TAKE another action the City Council deems appropriate.

IV. <u>BACKGROUND</u>

The City of Carson has provided funding for fine arts programming since the 1970's. With the City's recent budget challenges, this program was suspended until a time when it would be financially feasible for the City to restart the program. In the interim, on July 20, 2010, the City Council voted to waive fees for use of the Community Center for eight community groups that had received

funding in prior years: The Phillippine Chorale, Vivian McClure Theatre Productions, Carson Symphony, Apollo West Carson Players, Asociacion Cultural de South Bay of Great Los Angeles (Mariachi Academy of Carson), Sophisticated Dance, Samoan Federation of America, and Art in Motion, This action was taken in order to assist these groups with their fundraising activities as well as to hold meetings and rehearsals. Of the eight groups that were given this opportunity, three groups are currently using the community Center – The Mariachi Academy of Carson, Apollo West, and Sophisticated Dance.

Tonight, the City Council is asked to provide direction to staff regarding whether to extend this fee waiver to these three groups for all of Fiscal year 2012/13.

V. FISCAL IMPACT

When the groups were provided funding by the City they paid the "Resident Rate" for the use of the Community Center. At the time the fee waiver was approved, \$11,822.50 of unrealized revenue was calculated based on their previous usage in FY2009/10. Since July 20, 2010, the groups have not paid any fees. Consequently, the actual revenue that was not received was \$23,645.00. Room rental fees have increased in the interim; therefore, should the fee waiver be extended, the estimated revenue loss is \$16,322.25 for FY 2012/13.
