


# City of Carson Report to Mayor and City Council

July 3, 2012 Unfinished Business



#### I. <u>SUMMARY</u>

On June 19, 2012, Mayor Dear continued this item to the next regular meeting of July 3, 2012.

### II. <u>RECOMMENDATION</u>

**RECOMMENDATION** for City Council:

1. CONSIDER the request from Mayor Dear and PROVIDE direction.

#### III. <u>ALTERNATIVES</u>

- 1. DECLINE to remove from the table appointments to the Commissions, Committees, and Boards.
- 2. Take any action deemed necessary by the City Council.

### IV. <u>BACKGROUND</u>

At the regular meeting of the City Council on February 7, 1995, Council voted to comply with the provisions of Government Code Section 54974, Notice of Unscheduled Vacancy, which reads as follows:

"(a) Whenever an unscheduled vacancy occurs in any board, commission, or committee for which the legislative body has the appointing power, whether due to resignation, death, terminations, or other causes, a special vacancy notice shall be posted in the office of the clerk of the local agency, *the library designated pursuant to Section 54973*, and in other places as directed by the legislative body, not earlier than 20 days before or not later than 20 days after the vacancy occurs. Final appointment to the board, commission, or committee shall not be made by the legislative body for at least 10 working days after the posting of the notice in the clerk's office.

(b) Notwithstanding the subdivision (1), the legislative body may, if it finds that an emergency exists, fill the unscheduled vacancy immediately. A person

appointed to fill the vacancy shall serve only on an acting basis until the final appointment is made pursuant to this section."

On February 22, 2012, Mayor Dear informed the City Clerk's Office that Emily Griego regretfully resigned because of health issues; therefore, declared her position vacant on the Women's Issues Commission.

All posting requirements have been satisfied to fill the vacancy created on the Women's Issues Commission.

Applications of those individuals requesting appointment were previously provided under separate cover to the Mayor and City Council.

On March 6, 2012, Mayor Dear requested to remove from the table an appointment to the Women's Issues Commission for the limited purpose to consider the vacancy created on the Women's Issues Commission. The motion to consider Mayor Dear's request was denied by majority vote.

On February 21, 2012, Mayor Dear continued the Commission, Committee, and Board Apointments by Mayor Dear item to the next regular meeting and the City Council approved a motion to table the item excepting only the consideration of filling of vacancies on the Mobilehome Park Rental Review Board, Public Relations Commission, and the Carson Historical Committee.

On April 3, 2012, Mayor Dear requested to remove from the table Commission, Committee, and Board appointments and the motion to place all commissions, committees, and boards back on the table except for the Mobilehome Park Rental Review Board and the Carson Historical Committee and that all other commissions, committees, and boards were tabled by majority vote.

On March 20, 2012, the City Clerk's Office received a letter from Jim Brandt wherein he resigned from the Utility Users' Tax Citizens Budget Oversight Committee effective immediately due to his extended business travel out of the country.

On April 5, 2012, the City Clerk's Office received a copy of a letter from John Manley, Chairperson of the Veterans Affairs Commission, requesting that John Marcelin and Dr. James Whitmore be replaced due to excessive absences from meetings.

On April 19, 2012, John Graber informed the City Clerk's Office that he wished to decline his appointment to the Public Relations Commission due to a conflict with his work schedule, thereby creating a vacancy on the Public Relations

Commission.

All posting requirements have been satisfied to fill the vacancies created on the Utility Users' Tax Citizens Budget Oversight Committee and the Veterans Affairs Commission.

On May 1, 2012, Mayor Dear requested to remove from the table Commission, Committee, and Board appointments and the motion to leave all commissions, committees, and boards on the table until after the budget process except for the Mobilehome Park Rental Review Board and the Carson Historical Committee was approved by a majority vote.

On May 15, 2012, Mayor Dear continued this item to the next meeting of June 6, 2012.

On June 6, 2012, Mayor Dear requested to remove from the table Commission, Committee, and Board appointments and the motion to remove from the table Commission, Committee, and Board appointments failed to carry.

#### V. FISCAL IMPACT

Funds for commission member compensation are included in the respective work group accounts in the adopted FY 2011/12 budget.
