


City of Carson Report to Mayor and City Council

July 3, 2012 Unfinished Business



I. <u>SUMMARY</u>

On June 19, 2012, Mayor Dear continued this item to the the next regular meeting of July 3, 2012.

II. <u>RECOMMENDATION</u>

RECOMMENDATION for the Mayor:

1. CONSIDER or APPOINT members to the Mobilehome Park Rental Review Board and the Carson Historical Committee, with the approval of a majority of the entire City Council present, including the Mayor, as listed on Exhibit No. 1.

III. <u>ALTERNATIVES</u>

CONTINUE this item to another date.

IV. <u>BACKGROUND</u>

Previous to the adoption of Ordinance No. 04-1325, the Mayor and Members of the City Council each had one uncontested appointment to each Commission. The remaining vacancies of each commission were filled by the Mayor with ratification by the City Council.

With the adoption of Ordinance No. 04-1325 on November 16, 2004, the previous method of appointments is no longer in place. Ordinance No. 04-1325 provides in part that the City Council of the city of Carson has reviewed the method by which members of city commissions and boards are appointed under current provisions of the Carson Municipal Code in light of the requirements under State law for general law cities with a directly elected mayor, and found in Government Code Section 40605.

On December 21, 2004, Ordinance No. 04-1330 was adopted and amended the Carson Municipal Code for Sections 2701, 2736, 2751, 2762, 2796.2, 2798.2, 2799.2, 4702, 27100.2, 27101.2, 27102.2 27103.2, 27104.2, 27104.2 [SIC] (Codified as 27106.2) and 27105.2, regarding the number of votes required to make an appointment to, or effect a removal from, city commissions and boards.



Report to Mayor and City Council

July 3, 2012

The ordinance clarifies that appointment to or removal from city commissions and boards shall be by the Mayor with the approval of a majority of the entire City Council present, including the Mayor. Furthermore, appointments to fill existing vacancies shall be made by the Mayor with the approval of a majority of the entire City Council present, including the Mayor.

On April 19, 2011, this report was on the agenda at the request of Mayor Dear to consider and appoint new or reappoint commissioners and board members in accordance with the Carson Municipal Code. These provisions are pursuant to the requirements of Ordinance No. 04-1325, "An Ordinance of the City Council of the City of Carson, California, Amending the Carson Municipal Code, at Sections 2701, 2736, 2751, 2762, 2796.2, 2798.2, 2799.2, 4702, 27100.2, 27101.2, 27102.2 27103.2, 27104.2, 27104.2 [SIC] (Codified as 27106.2) and 27105.2, Regarding the Appointment and Removal of Members of City Commissions and Boards," which was adopted on November 16, 2004. The new terms will expire on March 31, 2013.

The current terms of said appointees will expire on March 31, 2013 with the exception of Relocation Appeals Board Members Ricardo Pulido and Harriett Russ (terms expire 3/31/12). The term of one Human Relations Youth Commissioner expired on 4/30/11. Also, terms of the Youth Commissioners will expire on June 30, 2012. However, the Carson Municipal Code provides in part that each Commission member shall continue to serve until a successor has been appointed by the Mayor with the approval of a majority of the entire City Council present, including the Mayor, and has qualified unless the City Council declares the position to be vacant.

All commissioners and board members were invited to submit a Commission/Board Appointment Application for consideration by Mayor Dear.

Applications of those individuals requesting appointment were previously provided under separate cover to the Mayor and City Council.

On February 21, 2012, Mayor Dear continued the Commission, Committee, and Board Apointments by Mayor Dear item to the next regular meeting and the City Council approved a motion to table the item excepting only the consideration of filling of vacancies on the Mobilehome Park Rental Review Board, Public Relations Commission, and the Carson Historical Committee.

On February 8, 2012, Mayor Dear informed the City Clerk's Office that Dr. Helen Abernathy-King was in a car accident and would be recovering for six months, therefore, declared her position vacant as the Public Relations Specialist on the Public Relations Commission. **City of Carson**

Report to Mayor and City Council

On February 8, 2012, Mayor Dear informed the City Clerk's Office that Ronald Shimokaji resigned from the Carson Historical Committee effective immediately, thereby, creating a vacancy on the Carson Historical Committee.

All posting requirements have been satisfied to fill the vacancies created on the Public Relations Commission and the Carson Historical Committee.

On March 6, 2012, Mayor Dear postponed his appointments to the Mobilehome Park Rental Review Board and the Carson Historical Committee. He appointed John Graber to the Public Relations Commission which was ratified by the City Council, thereby creating a vacancy on the Relocation Appeals Board.

All posting requirements have been satisfied to fill the vacancy created on the Relocation Appeals Board.

On March 20, 2012, Mayor Dear continued this item to the next regular meeting of April 3, 2012.

On April 3, 2012, Mayor Dear continued this item to the next regular meeting of April 17, 2012.

On May 1, 2012, Mayor Dear continued this item to the next regular meeting of May 15, 2012.

On May 1, 2012, Mayor Dear appointed Luris Bell to the Veterans Affairs Commission as an Ex officio member, thereby creating a vacancy on the Mobilehome Park Rental Review Board.

All posting requirements have been satisfied to fill the vacancy created on the Mobilehome Park Rental Review Board.

On June 6, 2012, Mayor Dear continued this item to the next regular meeting of June 19, 2012.

V. <u>FISCAL IMPACT</u>

Funds for commission member compensation are included in the respective work group accounts in the adopted FY 2011/12 budget.
