Inquired into the status of: 1) CDBG funding; 2) First-time Homebuyer Program; Neighborhood Pride Program; and requested that the City Council retain Economic Development General Manager Graves.

Harold Williams, 20113 Belshaw Avenue, Carson, California 90746

Inquired into the disposition of funds when property purchased as a landbank would be sold.

Upon inquiry, City Manager/Executive Director Biggs discussed the timeline of the transfer and the Oversight Board.

NEW BUSINESS DISCUSSION (Item 4)

CONSIDER SUPPORT FOR THE RELIEF EFFORTS OF THE TYPHOON SENDONG VICTIMS IN THE PHILIPPINES (CITY MANAGER)

(Council/Agency Member Gipson exited the meeting at 7:15 P.M.)

City Manager/Executive Director Biggs summarized the staff report and recommendation.

(Council/Agency Member Gipson reentered the meeting at 7:16 P.M.

Public Comments

The following persons offered comments:

Miriam Vazquez, 21413 Martin Street, Carson, California 90745

Felt that since the City of Carson was experiencing a crisis with the Redevelopment Agency, everyone must become self-supporting.

Ronald Shimokaji, 1512 E. Carson Street, Sp. 135, Carson, California 90745

Concurred with the staff recommendation and to ensure that the money goes to help the victims.

Jenny Vazquez, 21413 Martin Street, Carson, California 90745

Concurred that everyone must become self-supporting.

Mary Anne O'Neal, 16211 Visalia Avenue, Carson, California 90746

Referred to the staff report and noted that since there was no contribution from the City of Carson, the City Council had no authority to control funds.

Joaquin (Jun) Punsalan, Jr., 109 W. 224th Place, Carson, California 90745

Discussed his request for a fee waiver for the use of Veterans Park gymnasium for relief efforts of the Typhoon Sendong victims in the Philippines.

Raul Murga, 21111 Dolores Street, Carson, California 90745

Consurred with the staff recommendation and requested that the waiver amount be provided in future reports.

City/Agency Treasurer Avilla

Discussed the administrative handling of donations for past relief efforts.

RECOMMENDATION for the City Council:

TAKE the following actions:

- 1. REQUEST the City Treasurer to act as the custodian for Typhoon Sendong donations for a period of 90 days.
- 2. CONSIDER WAIVING FEES FOR Carson facilities needed to host a fundraiser.

ACTION: It was moved to request the City Treasurer to act as the custodian for Typhoon Sendong donations for a period of 90 days and to waive the fees for Carson facilities needed to host a fundraiser on motion of Santarina and seconded by Dear.

Amended Motion

During discussion of the motion, Mayor/Chairman Dear offered an amendment to the motion to direct the City Treasurer to dispose of proceeds raised by the fund-raising committee to a legitimate charitable group doing the work of aiding the victims in the Philippines, which was accepted by Santarina.

During discussion of the amended motion, the following comments were expressed:

Council/Agency Member Santarina

Requested that the City Treasurer coordinate the distribution of funds with one or two of the following suggested organizations: ABS-CBN Foundation; Catholic Bishops Conference for the Philippines in coordination with the International Catholic Relief for Charities; and Philippine National Red Cross with the Lanao Del Norte Assocation.

Council/Agency Member Davis-Holmes

Provided a copy of the appeal procedure for equipment and facility reduced fee waiver requests to City Manager Biggs and setting forth policy and procedure and requested that the City Manager bring back a policy for the fee waiver requests for special events and to provide procedures how such requests would be executed.

Joaquin (Jun) Punsalan, Jr., 109 W. 224th Place, Carson, California 90745

Reported that two fund-raising events were planned; however, there was no fee waiver for the second event to be held at the South Bay Pavilion.

City/Agency Treasurer Avilla

Stated that it was her intent to provide a report to the City Council on February 7 and discussed a timeframe within which any money with the City's name would be turned into the City Treasurer's Office and suggested that money could be turned into staff at Veterans Park for safekeeping as well.

Yolanda Punsalan, 109 W. 224th Place, Carson, California 90745

Upon inquiry, reported that payments could be made to Iligan City and Lanao Del Norte Association of Southern California, both non-profit organizations. Whereupon, City Treasurer Avilla subsequently determined that the City Treasurer's office need not act as a repository.

Substitute Motion

Council/Agency Member Davis-Holmes offered a substitute motion to waive the rental fees for the Veterans Park gymnasium on January 21, 2012, in the amount of \$1200; to inform the organizing committee that they would be responsible for all hard costs associated with the event, such as staff, insurance, and security, and that the fees were to be paid by the organizing committee prior to the event, which was seconded by Ruiz-Raber. Whereupon, Mayor Dear requested that the maker include that the organizing committee abide by all rules for groups which utilize City facilities, which was accepted by the maker and the second.

Council/Agency Member Gipson stated that he may not be available to attend the fund-raising event and that Mr. Punsalan could pick up a check for \$100.00 from him.
