




SUBJECT: CONSIDER AN AWARD OF A PURCHASE CONTRACT FOR ONE 2012 FORD F150 PICKUP TRUCK

I. SUMMARY

The Acting Purchasing Manager has received sealed bids for the purchase of one 2012 4x2 pickup truck with supercrew cab for use by the Transportation Services Division, Development Services Workgroup. Since the total cost of this purchase exceeds the amount that the City Manager may approve, the City Council is being asked to approve the award of the purchase contract.

II. RECOMMENDATION

AWARD a purchase contract in the amount of \$25,411.66 to Frontier Ford for the purchase of one 2012 4x2 Ford F150 pickup truck with supercrew cab.

III. ALTERNATIVES

TAKE any other action the City Council deems appropriate.

IV. BACKGROUND

In accordance with the procurement process stipulated in the Carson Municipal Code, bids were solicited for the purchase of one 4x2 pickup truck with supercrew cab, as described in City of Carson bid specification No. B12-03.

The bid packages were mailed to 15 vendors, four of which are based within the City of Carson (Exhibit No. 1). Prior to mailing the bid packages, Purchasing staff contacted each Carson vendor. The responses were that they did not have vehicles comparable to the specifications or simply were not interested.

The City Clerk posted the Notice of Bid as required by the Carson Municipal Code. On April 24, 2012, the bid was also published in the *Our Weekly* newspaper. On May 10, 2012, five bid responses were opened as received by the City Clerk's office with the following results:

The bids were reviewed by the Buyer, Acting Public Works Superintendent, and the Acting Supervisor of Transportation Services. Each bid was reviewed and evaluated for consistency with city bid specifications and utility requirements. The bid submitted by Frontier Ford of Santa Clara, CA is the lowest responsible bid.

A copy of City bid specification No. B12-03 is available in the office of the Acting Purchasing Manager, and informational copies have been previously provided to the Mayor and City Councilmembers.

The purchase of this truck is a new purchase which will support the Transportation Services Division due to the need for a vehicle for field activities and inspections relating to the Carson Circuit.

V. FISCAL IMPACT

The funds for this purchase contract will be included in the Prop A Budget (NTD Funds) for FY 2012/13 in account no. 18-80-500-002-8002.
