ITEM NO. (7) CONSIDERATION OF ADOPTION OF RESOLUTION NO. 12-006 TO AMEND THE CITY'S PERSONNEL RULES TO ADD A Y-RATING POLICY (ADMINISTRATIVE SERVICES)

Item No. 7 was heard at 2:16 A.M., on Wednesday, January 18, 2012.

Upon inquiry by Council Member Davis-Holmes, City Attorney Wynder referred to Page 4, Section 4, suggested amended language to read as follows and accepted with no objections heard:

"Section 4. Rule XI of the Personnel Rules is hereby amended by adding a Section 6 which shall read as follows:

Y-Rating. Except as specifically prohibited elsewhere, Y-ratings shall be given when persons or positions are reclassified, transferred or demoted downward for the City's convenience without considering an employee's job performance. (a) The practice of Y-rating is not to be confused with disciplinary involuntary demotion, salary range adjustments, or other normal personnel procedures. Y-ratings are sometimes, but not always associated with a reorganization and redistribution of duties and responsibilities within the City."
