ORDINANCE NO. 13-1509

AN ORDINANCE OF THE CITY OF CARSON, CALIFORNIA, AMENDING SECTION 3260.2 OF CHAPTER 2 OF ARTICLE III OF THE CARSON MUNICIPAL CODE TO UPDATE THE LIST OF DESIGNATED TRUCK ROUTES, ELIMINATE PARTS OF MAIN AND VICTORIA STREETS FROM THE LIST OF DESIGNATED TRUCK ROUTES, AND MODIFY OTHER OUTDATED REFERENCES IN THE TRAFFIC REGULATIONS CHAPTER

WHEREAS, the list of designated truck routes in the current Carson Municipal Code needs to be updated to be consistent with the designated truck route map that was approved by City Council in the General Plan update; and

WHERAS, the City Council directed staff to amend the Carson Municipal Code to eliminate Victoria Street between Main Street and Central Avenue and to eliminate Main Street between Broadway and Victoria Street from the list of designated truck routes; and

WHEREAS, the existing Carson Municipal Code refers to the "Traffic Manual," which is a document that is no longer in use in California; and "handicapped parking," which is a term that has been replaced in most documentation with the term "disabled person parking."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Section 3260.2 – "Designated Routes" of Part 7 – "Truck Regulations" of Chapter 2 – "Traffic Regulations" of Article III – "Public Safety" of the Carson Municipal Code is hereby amended to read, in its entirety, as follows:

"Section 3260.2 Designated Routes.

Commercial vehicles exceeding a maximum gross weight of 6,000 pounds shall use only the following streets or portions of streets within the City of Carson:

- (1) Alameda Street.
- (2) Albertoni Street.
- (3) Alondra Boulevard.
- (4) Artesia Boulevard.
- (5) Avalon Boulevard between Alondra Boulevard and Victoria Street, and between 223rd Street and south city limits.
- (6) Broadway.



- (7) Carson Street between I-405 southbound on/off ramps and Alameda Street connector road.
- (8) Central Avenue between Victoria Street and north city limits.
- (9) Del Amo Boulevard.
- (10) Figueroa Street.
- (11) Lomita Boulevard.
- (12) Main Street between Alondra Boulevard and Victoria Street, between Broadway and Torrance Boulevard, and between Sepulveda Boulevard and Lomita Boulevard.
- (13) Santa Fe Avenue.
- (14) Sepulveda Boulevard.
- (15) Torrance Boulevard between Main Street and west city limits.
- (16) Victoria Street between Figueroa Street and Main Street, and between Central Avenue and Wilmington Avenue.
- (17) Walnut Street between Broadway and Main Street, and between Avalon Boulevard and Central Avenue.
- (18) Wilmington Avenue.
- (19) 223rd Street."
- Section 2. The reference to the "California Department of Transportation Traffic Manual and/or the U.S. Department of Transportation Manual on Uniform Traffic Control Devices" in Section 3203 "City Traffic Engineer" of Part 1 "General Provisions and Violations" of Chapter 2 of Article III of the Carson Municipal Code is hereby amended to read "California Manual on Uniform Traffic Control Devices."
- **Section 3.** The references to "Handicapped Parking" in the titles of Sections 3253, 3253.1, 3253.2, and 3253.3 of Part 6 "Parking Regulations" of Chapter 2 of Article III of the Carson Municipal Code are hereby amended to read "Disabled Person Parking."
- **Section 4.** If any provision(s) of this ordinance or the application thereof to any person or circumstances is held invalid or unconstitutional by any court of competent jurisdiction, such invalidity or unconstitutionality shall not affect any other provision or application, and to this end the provisions of this ordinance are declared to be severable. The City Council hereby declares that they would have adopted this ordinance and each section, subsection, sentence, clause, phrase, part or portion thereof, irrespective of the fact that any one or more sections, subsections, clauses, phrases, parts or portions thereof be declared invalid or unconstitutional.
- **Section 5.** The City Clerk shall certify to the adoption of this ordinance, and shall cause the same to be posted and published in the manner required by law.
 - **Section 6.** This ordinance shall be effective 30 days following its adoption.
