SUBJECT: CONSIDERATION TO APPROVE A PROFESSIONAL SERVICES AGREEMENT WITH P.A. ARCA ENGINEERING, INC., TO PREPARE THE PROJECT PLANS, SPECIFICATIONS AND ESTIMATES FOR PROJECT NO. 1355: VETERANS PARK ATHLETIC FIELD RENOVATION

#### I. <u>SUMMARY</u>

On January 15, 2013, engineering staff submitted a Request for Proposals (RFP) to four consulting firms on the City's consultant list, which included two local engineering and land surveying firms. The RFP was for the preparation of construction plans, specifications and estimates (PS&E) for Project No. 1355: Veterans Park Athletic Field Renovation (Exhibits No. 1 and 2).

The two firms that submitted proposal packages were placed on the ranking list. The top ranked and most responsive and comprehensive firm is P.A. ARCA Engineering, Inc. Therefore, staff recommends that a Professional Services Agreement for this project be awarded to P.A. ARCA Engineering, Inc., for the negotiated amount of \$48,192.00

#### II. <u>RECOMMENDATION</u>

TAKE the following actions:

- 1. APPROVE a Professional Services Agreement with P.A. ARCA Engineering, Inc., for the preparation of construction plans, specifications and estimates for Project No. 1355: Veterans Park Athletic Field Renovation for a negotiated fee not-to-exceed \$48,192.00.
- 2. AUTHORIZE the Mayor to execute the Professional Services Agreement following approval as to form by the City Attorney.
- 3. MAKE the California Environmental Quality Act (CEQA) finding that the proposed Veterans Park Athletic Field Renovation is categorically exempt pursuant to Section 15301, 15301 (d) and 15301 (h) of the CEQA guidelines.
- 4. AUTHORIZE staff to record the "Notice of Exemption" in the office of the Los Angeles County Clerk, for Project No. 1355: Veterans Park Athletic Field Renovation.

#### III. <u>ALTERNATIVES</u>

- 1. DO NOT APPROVE the Professional Services Agreement.
- 2. TAKE another action the City Council deems appropriate.

#### IV. BACKGROUND

The Veterans Park Athletic Field Renovation project is listed in the City's Capital Improvement Program (CIP) for FY 2012/13. Veterans Park is located at 22400 Moneta Avenue. This 12-acre park is bordered by 223rd Street on the north, Moneta Avenue on the west, and residential units on the east and south.

The project consists of the renovation of the athletic field by regrading the surface, replacing additional soils where needed, removal and replacement of the existing irrigation system, installation of fencing, installation of a drainage system for the baseball field, and construction of a 3-foot retaining wall along 223<sup>rd</sup> Street to prevent erosion of the landscaped slope.

On April 15, 2008, the City Council adopted Resolution No. 08-057, approving the application for grant funds from the Los Angeles County Regional Park and Open Space District (Exhibit No. 3).

The original application was for Carson and Hemingway Parks playing field refurbishments. On July 7, 2008, the Los Angeles County Regional Park and Open Space District approved Grant No. 58B8-08-2189 in the amount of \$250,000.00 (Exhibit No. 4). The grant provides for the design, administration, and construction costs for playing field refurbishments at those two parks.

Since the Carson Park and the Hemingway Park playing fields were renovated under different projects, on April 10, 2012, the City and the Los Angeles County Regional Park and Open Space District amended the project agreement to use this grant for the Veterans Park Athletic Field Renovation project (Exhibit No. 5).

On January 15, 2013, the Engineering Services Division mailed a notice of RFP to four consulting firms on the City's consultant list, which included two local engineering and land surveying firms.

On February 6, 2013, two proposals were received. The proposals were reviewed and ranked by the City of Carson Engineering Services Division staff.

The (alphabetical) listing of the two firms is as follows:

- 1. P.A. ARCA Engineering, Inc.; Carson, CA
- 2. KEC Engineers, Inc.; Chino, CA

After a review of the proposals, P.A. ARCA Engineering, Inc., was ranked the highest and the most responsive firm for this project.

The evaluations and rankings were performed without regard to the consultant fee in accordance with Section 4526 of the Government Code. Section 4526 states, in

part, "... selection by a state or local agency head for professional services or private architectural, engineering, land surveying, or construction project management firms shall be on the basis of demonstrated competence and on the professional qualifications for the satisfactory performance of the services required." This section was written into the Government Code to prevent selection of consultants based solely on fees.

P.A. ARCA Engineering, Inc., is a Disadvantage, Minority Business Enterprise (DBE/MBE) company located in Carson, California. Its office consists of team members that have been providing surveying, planning, and civil engineering design services. The firm's Principal-In-Charge has over 46 years of civil engineering and surveying experience.

Staff is confident that P.A. ARCA Engineering, Inc. will provide superior service by assembling a project team with extensive experience in Geotechnical investigation, landscape and irrigation design, and expertise that is directly related to the RFP for the preparation of PS&E for Project No. 1355: Veterans Park Athletic Field Renovation.

Based on CEQA guidelines, the proposed Veterans Park Athletic Field Renovation is categorically exempt according to the following:

- Section 15301 of CEQA includes the type of existing facilities projects that are categorically exempt. The following sections apply to the Veterans Park Athletic Field Renovation project:
  - Section 15301 (d): Restoration or rehabilitation of deteriorated or damaged structures, facilities, or mechanical equipment to meet current standards of public health and safety, unless it is determined that the damage was substantial and resulted from an environmental hazard such as earthquake, landslide, or flood.
  - Section 15301 (h): Maintenance of existing landscaping, native growth, and water supply reservoirs (excluding the use of pesticides, as defined in Section 12753, Division 7, Chapter 2, Food and Agricultural Code).

The negotiated fee for professional services is \$48,192.00. Funds in the amount of \$250,000.00 are included in the adopted FY 2012/13 L.A. County Park District Grant fund budget. The Los Angeles County Regional Park and Open Space District Grant No. 58B8-08-2189, Account No. 22-80-999-004-8008/0135501, provides for \$250,000.00 of the total project cost. 


