I. <u>SUMMARY</u>

Since the City's budgets for FY 2013/14 have not been approved, the City cannot legally expend funds after the end of the fiscal year. Therefore, it is necessary for the City to adopt a resolution granting authorization to expend funds pending approval of the final budget appropriations.

II. <u>RECOMMENDATION</u>

WAIVE further reading and ADOPT Resolution No. 13-069, "A RESOLUTION OF THE CITY OF CARSON, CALIFORNIA, GIVING THE DIRECTOR OF ADMINISTRATIVE SERVICES LIMITED AND TEMPORARY AUTHORITY TO EXPEND FUNDS OF THE CITY, SUBJECT TO THE CITY COUNCIL'S APPROVAL OF THE DEMAND REGISTER, AS REQUIRED BY LAW, PENDING ADOPTION OF THE FY 2013/14 ANNUAL BUDGET."

IV. <u>BACKGROUND</u>

By adopting annual budgets, the Carson City Council authorizes the appropriation of funds to the various City accounts for expenditure during the year. At the end of each fiscal year, the authority to expend funds runs out. Since the City budgets have not been approved, the Director of Administrative Services does not have the authority to approve the expenditure of City funds after June 30, 2013. Therefore, a resolution allowing funds to be spent pending approval of the budgets is necessary for the City to operate in the interim period.

RESOLUTION NO. 13-069

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, GIVING THE DIRECTOR OF ADMINISTRATIVE SERVICES LIMITED AND TEMPORARY AUTHORITY TO EXPEND FUNDS OF THE CITY, SUBJECT TO THE CITY COUNCIL'S APPROVAL OF THE DEMAND REGISTER, AS REQUIRED BY LAW, PENDING ADOPTION OF THE FY 2013/14 ANNUAL BUDGETS

THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

- Section 1. The Director of Administrative Services is hereby authorized to expend funds of the City, subject to the City Council's approval of the Demand Register, as required by law, for the purpose of paying ongoing City expenses until budgets are adopted by the City Council, or September 30, 2013, whichever occurs first.
- **Section 2**. The level of such expenditures and authorization is limited to the FY 2012/13 level of appropriations previously approved by the City Council, and those items that the City Council has subsequently authorized by separate Council action.
- **Section 3**. The City Clerk shall certify to the passage and adoption of this resolution; shall enter the same in the book of original resolutions of said City; and shall make a minute order of the passage and adoption thereof in the records of the proceedings of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.
