I. SUMMARY

On June 18, 2013, Mayor Dear continued his remaining appointments to the next regular meeting of July 2, 2013, as listed on Exhibit No. 1.

On June 18, 2013, the motion to only allow residents of Carson to be considered on the Public Relations Commission was approved by a majority vote, thereby, removing Lori Drengson (Public Relations Specialist), Sweeney Mae Montinola (Public Relations Specialist), Jocelyn Rios (Alternate Member No. 1), and Catherine Davis (Alternate Member No. 2) and creating vacancies on the Public Relations Commission. Also, Mayor Dear appointed Lori Drengson, Sweeney Mae Montinola, Jocelyn Rios, and Catherine Davis as Ex officio members to the Public Relations Commission.

All posting requirements have been satisfied to fill the vacancies created on the Public Relations Commission (Exhibit Nos. 2 and 3).

On June 24, 2013, the City Clerk was notified by Housing Program Manager Freschauf that Mary Pitman passed away on June 21, 2013, thereby, creating a vacancy on the Mobilehome Park Rental Review Board (Park Owner Member).

All posting requirements have been satisfied to fill the vacancy created on the Mobilehome Park Rental Review Board (Exhibit Nos. 4 and 5).

II. RECOMMENDATION

Mayor Dear to CONSIDER, APPOINT, or REAPPOINT members to the Commissions, Committees, and Boards in accordance with Ordinance No. 04-1330, with the approval of a majority of the entire City Council present, including the Mayor, as listed on Exhibit No. 1.

III. ALTERNATIVES

CONTINUE this item to another date.

IV. BACKGROUND

Previous to the adoption of Ordinance No. 04-1325, the Mayor and Members of the City Council each had one uncontested appointment to each Commission. The remaining vacancies of each commission were filled by the Mayor with ratification by the City Council.

With the adoption of Ordinance No. 04-1325 on November 16, 2004, the previous method of appointments is no longer in place. Ordinance No. 04-1325 provides, in part, that the City Council of the City of Carson has reviewed the method by which members of City commissions, committees, and boards are appointed under current provisions of the Carson Municipal Code in light of the requirements under State law for general law cities with a directly elected mayor, and found in Government Code Section 40605.

On December 21, 2004, Ordinance No. 04-1330 was adopted and amended the Carson Municipal Code for Sections 2701, 2736, 2751, 2762, 2796.2, 2798.2, 2799.2, 4702, 27100.2, 27101.2, 27102.2, 27103.2, 27104.2, 27104.2 [SIC] (Codified as 27106.2) and 27105.2, Regarding the Number of Votes Required to Make an Appointment to, or Effect a Removal from, City Commissions and Boards. The ordinance clarifies that appointment to or removal from City commissions, committees, and boards shall be by the Mayor with the approval of a majority of the entire City Council present, including the Mayor. Furthermore, appointments to fill existing vacancies shall be made by the Mayor with the approval of a majority of the entire City Council present, including the Mayor.

This report was initially presented on the April 2, 2013, agenda at the request of Mayor Dear to consider and appoint new or reappoint commissioners, committee and board members in accordance with the Carson Municipal Code. These provisions are pursuant to the requirements of Ordinance No. 04-1325, "An Ordinance of the City Council of the City of Carson, California, Amending the Carson Municipal Code, at Sections 2701, 2736, 2751, 2762, 2796.2, 2798.2, 2799.2, 4702, 27100.2, 27101.2, 27102.2, 27103.2, 27104.2, 27104.2 [SIC] (Codified as 27106.2) and 27105.2, Regarding the Appointment and Removal of Members of City Commissions and Boards," which was adopted on November 16, 2004. The new terms will expire on March 31, 2015.

The current terms of said appointees expired on March 31, 2013, with the exception of Relocation Appeals Board Member Rochelle Hall (term expires 3/31/14), Ricardo Pulido and Harriett Russ (terms expired 3/31/12). The terms of the Human Relations Youth Commissioners expired on 4/30/13. Also, terms of the Youth Commissioners expired on June 30, 2012. However, the Carson Municipal Code provides, in part, that each Commission, Committee, or Board member shall continue to serve until a successor has been appointed by the Mayor

with the approval of a majority of the entire City Council present, including the Mayor, and has qualified unless the City Council declares the position to be vacant.

All commissioners, committee and board members were invited to submit a Commission/Committee/Board Appointment Application for consideration by Mayor Dear.

Applications of those individuals requesting appointment were previously provided under separate cover to the Mayor and City Council.

On April 2, 2013, Mayor Dear continued this item to the next regular meeting of April 16, 2013.

On April 16, 2013, Mayor Dear continued this item to the next regular meeting of May 7, 2013.

On May 7, 2013, Mayor Dear continued his remaining appointments to the next regular meeting of May 21, 2013.

On May 21, 2013, Mayor Dear continued his remaining appointments to the next regular meeting of June 4, 2013.

On June 4, 2013, Mayor Dear continued his remaining appointments to the next regular meeting of June 18, 2013.

On June 4, 2013, the City Clerk was notified that Theresa Griego-Aguilar passed away on May 31, 2013, thereby, creating a vacancy on the Women's Issues Commission.

All posting requirements have been satisfied to fill the vacancy created on the Women's Issues Commission.

V. FISCAL IMPACT

Funds for commission and board member compensation are included in the respective work group accounts in the proposed FY 2013/14 budget.

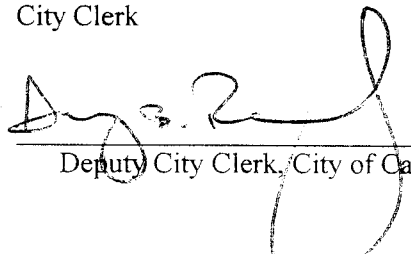
