SUBJECT: CONSIDERATION OF FEE WAIVER FOR THE USE OF THE CONGRESSWOMAN JUANITA MILLENDER MCDONALD COMMUNITY CENTER FOR A 5K WALK-A-THON SPONSORED BY THE ERASTO R. BATONGMALAQUE FOUNDATION

#### I. SUMMARY

On September 5, 2013, Dr. Jenny Batongmalaque of the Erasto R. Batongmalaque (E.R.B.) Foundation requested and was provided information on the cost to hold a walk-a-thon at the Congresswoman Juanita Millender McDonald Community Center at Carson on October 20, 2013, to honor the 69<sup>th</sup> Anniversary of Leyte Landing, where General Douglas MacArthur made good on his promise of "I shall return" which he made on March 30, 1942, after his arrival in Australia from the Philippines after his escape from Corregidor. This was after the Americans lost the Philippines to Japan. The walk-a-thon is for the benefit of veterans and seniors. Dr. Batongmalaque would like fees associated with the event to be waived.

#### II. RECOMMENDATION

PROVIDE direction to staff regarding whether or not to waive fees for the use of the Congresswoman Juanita Millender McDonald Community Center in the City of Carson for the Erasto R. Batongmalaque Foundation to hold a 5K walk-a-thon on Sunday, October 20, 2013.

#### III. ALTERNATIVES

TAKE another action the City Council deems appropriate.

#### IV. <u>BACKGROUND</u>

Dr. Jenny Batongmalaque, Officer of the E.R.B. Foundation, would like to sponsor a 5K walk-a-thon on the East Lawn of the Congresswoman Juanita Millender McDonald Community Center in the City of Carson, where the Rizal Monument now stands. The cost for the space and equipment is \$597.00 plus a \$250.00 refundable deposit for a total of \$847.00. The request also includes use of restroom facilities as well as parking.

An adverse impact of this event on functions taking place within the Congresswoman Juanita Millender McDonald Community Center is expected as there will be 11 other events taking place during this same time period which will require significant parking and access to the community center.
