#### **Public Comments**

#### **Barbara** Post

Commended the Mayor and City Council for asking pertinent questions and working with Carousel Tract residents.

#### Stephanie Piazza

Articulated the concerns of Carousel residents with regard to the perceived failure of the Regional Water Board to respond to their concerns of pollution in their neighborhood.

#### Dr. Rita Boggs

Petitioned the City Council to add Dr. Lauren Pinter Brown, a physician at UCLA, to the expert witness panel to address the problems of benzene. She indicated that residents were told that this group did not have the authority to move the residents out from that site that had to come from the EPA. She stated that the people that would be most affected by this is the children.

#### **Bob Bococh**

Asserted that the Regional Water Control Board in the administrative law branch of the government has hindered the process and has actually become the problem. What makes the Carousel Tract so unique in the state of California is that people are living on a cleanup and abatement order site. He stated that very early on in the process, all property owners were issued 'no contact' letters with just the surface soils and every single home sub slab sample has indicated elevated levels of benzene and methane. He cited a broken system that needs to be fixed and that he is looking forward to May 7, 2013.

Mayor/Agency Chairman/Authority Chairman Dear directed staff to coordinate with the Water Quality Control Board, Barbara Post, and Bob Bococh to conduct a special City Council meeting one or two weeks from today to address these issues.

Council Member/Agency Member/Authority Commissioner Davis Holmes asked that Mr. Bococh address the usefulness of the nuisance lawsuit. Mr. Bococh affirmed that the lawsuit demonstrated community unity to the courts and was very appropriate.

#### Paul Randall

Argued against the hiring of another city manager due to budget constraints and the loss of redevelopment funds.

#### Harry Dube

Petitioned park management officials to stop harassing senior citizens to remove their sheds.

#### Modesto Pulido

Invited the City Council to attend the Women's Club Special Concert to be held Sunday, April 28, 2013 in the Carson Community Center from 3p.m. to 5 p.m. Tickets are \$20.

#### Johan Schilling

Petitioned the City Council to address the dilapidated fence in his backyard at 1808 Helmick Street, Carson.

#### Larry Shimokoji, Chairman of the Beautification Committee

#### **Dorothy Dominguez**

Requested speed bumps or stop signs on Martin Street and Water Street to slow down traffic. She also invited the City Council to attend the Stroke Center Reunion to be held Friday, May 3, 2013 at 12 noon in the Carson Community Center Hall. Tickets are \$15.

# CONSIDERATION OF APPROVAL OF THE FIRST AMENDMENT TO THE CONSTRUCTION CONTRACT WITH CWS SYSTEMS, INC., FOR PROJECT NO. 1223: CARSON PARK MASTER PLAN (PUBLIC WORKS)

This item was heard after Item No. 22 under the City Council agenda.
