#### I. SUMMARY

This matter is on the agenda at the request of Mayor Dear.

The Public Relations Commission has historically been comprised of a mix of atlarge members and members who must be public relations professionals. Past practice is that the public relations professionals could be non-residents. However, past practice has been inconsistent with the requirements of the Municipal Code. To bring the code into compliance with "past practice," the City Council is asked to consider introduction of the attached ordinance.

Draft Ordinance No. 13-1524 was first on the agenda on June 18, 2013. During that meeting the City Council took no action to adopt the ordinance (Exhibit Nos. 1 and 2). Mayor Dear is asking the Council to introduce the attached ordinance or it will be necessary to change the City's current practice of making commission appointments.

## ORDINANCE NO. 13-1524

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE CARSON MUNICIPAL CODE REGARDING THE COMPOSITION AND QUALIFICATIONS OF THE MEMBERS OF THE PUBLIC RELATIONS COMMISSION

NOW, THEREFORE, the CITY COUNCIL of the CITY of CARSON, CALIFORNIA, does hereby ordain as follows:

SECTION 1. The first sentence of Section 27105.2 of the Carson Municipal Code is amended, in part, to read as follows: "The Public Relations Commission shall consist of nine (9) members, each of whom shall have the qualifications hereinafter set forth four (4) of whom shall be appointed at large and five (5) of whom shall be public relations professionals, who shall assist the city in developing a public relations statement for the city and a comprehensive community relations plan to enhance positive and proactive publicity for the city of Carson (new text, if any, is identified in bold & italics, deleted text, if any, is identified in strike through).

SECTION 2. Section 27105.8 of the Carson Municipal Code is amended, in part, to read as follows: "Each member of the Public Relations Commission shall be a resident of the City of Carson shall be and remain a resident of, or have a place of employment or business in, the city of Carson, and be at least eighteen (18) years of age at the time of the member's appointment" (new text, if any, is identified in bold & italics, deleted text, if any, is identified in strike through)

SECTION 3. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is, for any reason, held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council of the city of Carson hereby declares that it would have adopted this Ordinance and each section, subsection, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, phrases, or portions thereof may be declared invalid or unconstitutional.

SECTION 4. This Ordinance shall be in full force and effect thirty (30) days after its second reading and adoption.

SECTION 5. The City Clerk shall certify to the passage and adoption of this Ordinance by the City Council of the city of Carson and shall cause a summary of this ordinance to be published in accordance with Government Code § 36933.

## IV. BACKGROUND

The Public Relations Commission is described in the City's special information directory as:

Consists of nine (9) members, four (4) of the members must be members-at-large and five (5) must be public relations professionals responsible for developing a public relations statement for the City and a comprehensive community relations plan to enhance positive and proactive publicity for the City of Carson. Assists with improving public relations priorities and channels of communication with the local media, community, public institutions and business.

Since its inception, the Public Relations Commission has had some of the public relations specialist positions filled by non-residents, generally people employed and working with companies located in Carson. These appointments have been made by the Mayor and ratified by the City Council.

This has been beneficial to the operation of the Commission and in achieving the City's public relations goals. In order to continue to allow for non-resident members, including some of the currently seated Commissioners, an amendment to section 27105.8 - Membership Qualifications related to the Public Relations Commission is recommended to be adopted to provide for the same language as in the ordinance sections that relate to the Economic Development Commission and the Public Works Commission which allow for members who have a place of employment or business in the City of Carson.
