Received a status report no reportable action was taken on the item nor was any solicited.

Council Closed Session Item No. 3A

Briefed the Council on the status of that litigation and asked for authority to resolve the remainder litigation that was unanimously granted by City Council; briefed for the residents the outcome of the litigation that the community would be pleased that the City of Carson was the only City to hold out on the last round of

settlement negotiations. The City Council unanimously rejected the county's last settlement proposal which caused the special litigation counsel to go back and further negotiate the settlement. As a result of the City Council's determination on this, the City's share of the settlement has risen to \$1,900,619.00. The Council unanimously accepted that settlement and authorized the preparation of an appropriate settlement agreement with the County of Los Angeles regarding that which represents a significant increase over the County's latest offer to settle with the City Attorney and for the City Attorney's concern was an excellent result.
