Mary Anne O'Neal

Recognized Parks and Recreation staff for their immediate response to an emergency situation during the grand opening celebration of Carson Park.

Paul Randall

Thanked Jacquelyn Acosta and her staff for conducting the best Utility User Tax meeting he has attended in a long time.

Olivia Verrett

Encouraged the citizens of Carson to attend Mayor Dear's 4th Annual 4th of July Fireworks Celebration to be held at the Stub Hub Center. Transportation will be provided from the Carson Community Center.

Tommie Williams

Expressed complete disappointment with the dismissal of former City Manager/Executive Director David Biggs.

Monica Havnes

Petitioned the City Council to consider a resolution of statement of disapproval for the Vivid Cabaret Gentleman's Club located adjacent to Del Amo Boulevard and Wilmington Boulevard. She expressed concerns for its negative impact on Carson's property values, neighboring elementary schools, and a possible influx of sexual offenders in the area. She further urged the residents to contact Los Angeles

County Board Supervisor Mark Ridley-Thomas at (213) 974-2222 and express their dissatisfaction with this business in the area.

Council Member/Agency Member/Authority Commissioner Davis Holmes notified Ms. Haynes that she had previously requested that this item be placed on the agenda at the next City Council meeting.

Council Member/Agency Member/Authority Commissioner Gipson mentioned that the business is located outside the City's jurisdiction.

Vera Robles DeWitt

Requested an item be placed on the agenda regarding an open and transparent discussion concerning the absence of meeting minutes on the council agenda. She charged the City Clerk with taking six days of travel in lieu of completing the Minutes and commented on the actions or lack of actions taken on the City's third commercial hauler.

Announced the passing of Mobile Home Board Member Mary Pittman.

Brenda Ramirez

Requested current events from Parks and Recreation staff on the City's cable access channel and stop signs at 223rd Street, Edgar Street, Lucerne Street, and Wilmington Avenue due to unsafe truck traffic. Ms. Ramirez also mentioned Toyota's commitment to constructing a traffic signal at 223rd and Wilmington Avenue; however she indicated that no action has been taken.

Mayor/Agency Chairman/Authority Chairman Dear directed Acting City Manager/Executive Director Acosta to conduct a traffic survey on the feasibility of installing a traffic signal at 223rd Street and Lucerne Street. Mayor Dear also confirmed that the intersection of 223rd Street and Wilmington Avenue will be revamped and converted as part of the 405 Freeway project.

Acting Director of Public Works/City Engineer Abolfathi also mentioned that traffic signals from 223rd Street to 220th Street will be synchronized to eliminate congestion on Wilmington Avenue.

Council Member/Agency Member/Authority Commissioner Davis Holmes requested the status of Toyota's commitment to installing a traffic signal at 223rd Street and Wilmington Avenue.

Acting City Manager/Executive Director Acosta indicated that staff would respond to the request in a memorandum.

Mila Boyer

Asked if former City Manager/Executive Director Biggs was terminated prior to the end of his contract.

City/Authority/Agency Attorney Wynder explained that the parties agreed upon a joint press release, in which they acknowledge that David Biggs' separation is in accordance with the municipal code and the provisions of his contract, both of which provide that certain sums will be paid to him on the termination of his employment relationship.

Council Member/Agency Member/Authority Commissioner Gipson directed the Acting City Manager/Executive Director Acosta to post an item on the agenda concerning the third commercial hauler.

Denise Hunt

Informed the City Council that the \$116,000 invoice for HVAC services is due to the City's use of Chem Pro and Siemens. Moreover, a couple of pieces of million dollar equipment on top of the community center had to be shipped to North Carolina to be repaired which cost approximately \$50,000.

Robert Lesley

Announced an upcoming meeting to address California Water Service's proposal to increase water rates. Mr. Lesley indicated that he would report back the information to the appropriate agencies within the City and further questioned the appropriateness of discussing personnel issues in a public forum.
