#### I. SUMMARY

Resolution No. 14-023 (Exhibit No. 1) presented to the City Council for adoption, amends the existing Resolutions of Salary and Benefits for Unclassified Management Employees to address the elimination of the City's Employer Paid Member Contributions (EPMC) effective March 1, 2014.

Resolution No. 14-024 (Exhibit No. 2) presented to the City Council for adoption, amends the existing Resolutions of Salary and Benefits for the City Clerk and City Treasurer to address the elimination of the City's Employer Paid Member Contributions (EPMC) effective March 1, 2014.

#### II. <u>RECOMMENDATION</u>

#### IV. <u>BACKGROUND</u>

The City successfully completed negotiations with the City's various represented bargaining units. As a result of these negotiations, it was agreed that effective March 1, 2014, the City would eliminate the CalPERS Employer Paid Member Contributions (EPMC) for all represented employees. The Resolutions eliminating EPMC for all represented employees are being presented separately to City Council tonight, and if approved, they will officially eliminate EPMC for all full-time represented employees. Additionally, staff is recommending that the EPMC be eliminated for the City's unrepresented management employees, as well as the City Clerk and City Treasurer.

Consequently, the Resolution of Salary and Benefits for Unclassified Management Employees has been revised to incorporate language that will address the elimination of the EPMC. Additionally, Resolution Nos. 10-077, 11-028 and 12-090 are being merged into Resolution No. 14-023, one comprehensive Resolution, to encompass the current salary and benefits afforded to Unclassified Management Employees.

The Resolution of Salary and Benefits for the City Clerk and City Treasurer has been revised to incorporate language that will address the elimination of the EPMC. Additionally, Resolution Nos. 06-091 and 12-090 are being merged into Resolution No. 14-024, one comprehensive Resolution, to encompass the current salary and benefits afforded to the City Clerk and City Treasurer.

#### V. <u>FISCAL IMPACT</u>

The City will no longer pay the member contributions on behalf of the unclassified management employees or the City Clerk or the City Treasurer.
