Successor Agency Item No. 3:

<u>Carmen Vargas, 633 W. 5th Street, Los Angeles, California 90071, Senior Vice President, Cabrera Capital Markets</u>

Thanked the City Council for its consideration/selection for underwriter in connection with the issuance of refunding bonds by the Successor Agency.

Council Item No. 18:

Pamela Penn, representing Pastor Alton Tremble, Glory Christian Fellowship International Church Voiced her support for the position and ongoing discussions between the City of Carson, Watson Land, Waste Management and other community property owners concerning taking specific steps to relocate the waste transfer station.

Pilar Hoyos, Watson Land Company

Expressed their appreciation of the City of Carson and staff for the work it has begun for the discussions with Waste Management regarding the transfer station on Main Street; reported that Watson Land Company has also met with Waste Management staff, and they are aware of the letter written by Porsche wherein residents voiced concerns for odor control mitigation and character of the area; encouraged the City to take timely and specific actions to look at the mitigation of the now incompatible land use and, from a historical standpoint, it is important to know that this area was designated the gateway to the City because of its location in the 2000 General Plan.

Connie Turner, Regional Manager of Local Public Affairs, representing Southern California Edison (SCE)

Introduced Mr. Damon Hannaman.

<u>Damon Hannaman, Account Manager, Business Customer Division of SCE</u>

Narrated a slideshow presentation of the energy efficiency programs offered by SCE.

Council Member/Authority Commissioner/Agency Member Davis Holmes asked that the item be advanced in order to hear the staff presentation and was accepted with no objections heard.

Council Item No. 4:

Paz Villanueva Velasquez, 23802 Ronan Avenue, Carson, California 90745

Ms. Villanueva was not in attendance when called to speak.

Miriam Vasquez

Informed the City Council that she received a court citation that a Monette Gavino -- a Public Relations Committee member -- is suing her. She also reported that she had been advised by telephone by the secretary to the Acting City Manager/Acting Authority Executive Director/Acting Agency Executive Director Acosta that Ms. Acosta was unable to meet with her due to the workplace restraining order. She added that Monette Loretizo works with the Mayor as a volunteer.

City/Authority/Agency Attorney Wynder informed Ms. Vasquez that the City Attorney's Office received allegations of workplace violence directed against her and, as authorized by the Workplace Violence Act and relevant state laws, they applied to the Superior Court on behalf of the Mayor's Intern for the issuance of workplace restraining order and to set a hearing date for a workplace violence permanent restraining order. The court granted the temporary order, the order was served, and process servers filed a declaration. A hearing will be held on December 27, 2013, to determine if that temporary restraining order should become a permanent workplace restraining order.

Ms. Vasquez affirmed that she knew her rights, and she is legal citizen who should be respected. She requested that Ms. Loretizo be removed from being a representative of the City of the Carson according to the Code of Ethics and because she is an illegal immigrant.

City/Authority/Agency Attorney Wynder advised Acting City Manager/Acting Authority Executive Director/Acting Agency Executive Director Acosta to not engage in discussions regarding this matter.

Urged the City Council to remember the reason for the season.

Requested clarification regarding the bond issues that are proposed to be refunded; whereupon, City/Authority/Agency Treasurer Avilla responded that the approval of this item authorizes the City to refund and refinance bonds at a lower interest rate. She inquired asked if this included the bonds issued for The Boulevards; whereupon, Acting City Manager/Acting Authority Executive Director/Acting Agency Executive Director Acosta reported that these bonds were issued in 2003 and there are five different bond issues being refunded for the purpose of interest rate savings.

Requested additional information regarding the staff report; whereupon, Acting City Manager/Acting Authority Executive Director/Acting Agency Executive Director Acosta explained that this item pertains to the City working with the federal government on providing environmental mitigation related to the Alameda Corridor.

Amanda Sanchez, Educator, Magnolia Science Academy 3, 1254 E. Helmick Street, Carson, CA 90746

Requested that the City Council consider providing financial assistance in the amount of \$25,000 for 25 students to participate in an educational tour to Washington, D.C. and New York City in Spring, 2014, and distributed copies of an informational handout.

Tyler Johnson, Student at Magnolia Science Academy 3

Urged the City Council to support their aspirations to participate in the educational tour to Washington, D.C., and New York City.

Mayor Pro Tem/Authority Vice Chairman/Agency Vice Chairman Santarina shared a personal recollection when he took 18 Carson High School students to the East Coast in 1999 and articulated his support for this worthwhile travel expenditure.

Council Member/Authority Commissioner/Agency Member Robles requested the date of the trip; whereupon, Ms. Sanchez indicated that the trip will take place during Spring Break, April 14-18, 2014. He made a commitment to her that they will raise the \$20,000 needed to travel to the East Coast. Whereupon, she clarified that \$20,000 was half the cost for 25 students; conversely, fundraising events and donations from friends and family will cover the remainder of the required expenditure.

Mayor Pro Tem/Authority Vice Chairman/Agency Vice Chairman Santarina invited Ms. Sanchez and Mr. Johnson to meet with the Mayor and Members of the City Council to discuss activities to make their trip successful and memorable.

Upon inquiry by Council Member/Authority Commissioner/Agency Member Davis-Holmes, Ms. Sanchez reported that many of the 25 students are Carson residents; however, some are from Gardena.
