SUBJECT: CONSIDER THE APPROVAL OF A PURCHASE ORDER FOR THE RESURFACING OF THE OUTDOOR BASKETBALL COURTS AT VARIOUS PARKS

#### I. SUMMARY

The outdoor basketball courts at Anderson Park, Calas Park, Carriage Crest Park, Del Amo Park, Dolphin Park, Dominguez Park, Hemingway Park, Mills Park, Scott Park, Stevenson Park, and Veterans Park are in serious need of renovation. On April 1, 2014 request for quotes were mailed to five vendors. On April 30, 2014, one quote was received from Taylor Tennis Courts, Inc. (Exhibit No. 1) and evaluated by the Public Works Maintenance Division staff.

#### II. RECOMMENDATION

- 1. AUTHORIZE the issuance of a purchase order to Taylor Tennis Courts, Inc., in the amount of \$72,074.00 for the resurfacing of the outdoor basketball courts at eleven parks.
- 2. AUTHORIZE the expenditure of a construction contingency, if necessary, in an amount not-to-exceed \$7,207.40 (10%) for unforeseen repairs that may be required to complete this project.

#### III. ALTERNATIVES

- 1. DO NOT APPROVE the purchase order
- 2. TAKE another action the City Council deems appropriate.

### IV. BACKGROUND

There are outdoor basketball courts at the following eleven City parks: Anderson, Calas, Carriage Crest, Del Amo, Dolphin, Dominguez, Hemingway, Mills, Scott, Stevenson, and Veterans that are in dire need of resurfacing. The scope of work generally involves preparing the existing surface for application of new surface and re-painting of its markings.

On April 30, 2014, one out of five requested quotes was received as summarized below:

Although only one quote was received, staff believes that this quote amount is reasonable, based on the comparison to the original FY 2013/14 Park Development Fee fund budget cost estimate; and that re-bidding the job will not result in a more favorable quote and will delay the park improvements without any additional public value.

Staff reviewed the quote and finds that the quote provider, Taylor Tennis Courts, Inc., is a bona fide contractor from Anaheim. The selected contractor is a non-Disadvantage Business Enterprise company and will not be using a sub-contractor for any portion of the work. Staff also verified that the contractor has completed similar projects in an acceptable manner. Use of prevailing wage rates is incorporated in the bid amount as specified in the bid package. Staff anticipates that the renovation will begin in mid-July 2014, and be completed by the end of August 2014. In order to minimize the inconvenience to the patrons, the Public Works Maintenance Division staff will continue on-going discussions with the recreation staff and coordinate the anticipated work schedule according to the activities scheduled at the parks during this renovation.

## V. FISCAL IMPACT

The estimated cost for these projects is \$79,281.00. Funds for these eleven resurfacing projects are budgeted in the FY 2013/14 Park Development Fee Fund budget.
