SUBJECT: CONSIDER A FEE WAIVER EXTENSION FOR USE OF THE CARSON DOMINGUEZ ROOM AND CITY EQUIPMENT AT THE CONGRESSWOMAN JUANITA MILLENDER-MCDONALD COMMUNITY CENTER FOR DR. JENNY BATONGMALAQUE'S TOWN HALL MEETINGS FOR SENIOR CITIZENS

I. SUMMARY

This item has been submitted at the request of Mayor James Dear.

Since 2010, the City has provided a fee waiver to the Erasto R. Batongmalaque Foundation for the use of the Carson Dominguez Room and City equipment to hold town hall meetings for the City's seniors (Exhibit Nos. 1 through 4). Tonight, the City Council is asked to extend this fee waiver for another 12 months, from September 2014 through August 2015.

II. <u>RECOMMENDATION</u>

CONSIDER and PROVIDE direction to staff.

III. <u>ALTERNATIVES</u>

- 1. APPROVE a fee waiver for the use of the Carson Dominguez Room for all 12 town hall meetings that will take place monthly from September 2014 through August 2015.
- 2. APPROVE a fee waiver for the use of the Carson Dominguez Room for less than all 12 town hall meetings.
- 3. DECLINE the request.
- 4. TAKE another action the City Council deems appropriate.

IV. <u>BACKGROUND</u>

Since 2010, the City Council has approved a fee waiver for the use of the Carson Dominguez Room and equipment – tables and chairs - for monthly senior town hall meetings presented by the Erasto R. Batongmalaque (ERB) Foundation. This event provides seniors the opportunity to learn about a variety of topics such as health and longevity, and advocacy and coalition building. Additionally, sales representatives from L.A. Health Plan, which is affiliated with the Batongmalaque Foundation, are present for these meetings.

During the past four years, the fee waiver has been extended several times. At its September 6, 2011, meeting, the City Council approved another extension, but added the following stipulations (Exhibit No. 3):

- An effort be made to recoup the hard costs the City is not receiving due to the fee waiver
- If an individual or organization requests the Carson Dominguez Room on a day in which Dr. Jenny is using the room for the ERB Foundation, the individual or group that is willing to pay for the room be given the room to use. Dr. Jenny would be given notice that her event canot take place in that room.

On July 17, 2012, the City Council approved the most recent extension which was for 24 months. Tonight, the City Council is asked to consider a 12-month extension of a room and equipment fee wiaver for these senior town hall meetings.

V. FISCAL IMPACT

Should the City Council approve extending the fee waiver for the use of the Carson Dominguez Room and related city equipment, the city will not realize approximately \$14,352.00 in revenue. This grand total is based on \$600.00 for use of the room, \$360.00 for tables, and \$236.00 for chairs, for a total of \$1,196.00 per meeting for 12 months.
