I. <u>SUMMARY</u>

This report is on the agenda at the request of Mayor Dear to consider member assignments to any City Council Committee; the status of any City Council Committee whether active or inactive; and/or to create new City Council Committees; and appoint chairpersons.

At the budget workshop on July 7, 2014, Mayor Pro Tem Santarina expressed his interest to serve on the Fireworks Stands Council Committee; whereupon, Mayor Dear requested that member assignments to City Council Committees be placed on the agenda for consideration by the City Council.

II. RECOMMENDATION

Mayor Dear to TAKE the following actions:

- 1. CONSIDER the status of any City Council Committee as listed on Exhibit No. 1.
- 2. CONSIDER and CREATE any new City Council Committees in accordance with Standard Management Procedure No. 1.45 and DETERMINE if the same are "standing committees" or "ad hoc committees." (Exhibit No. 2)
- 3. DESIGNATE member assignments to the City Council Committees.
- 4. APPOINT a chairperson to each City Council Committee.

III. <u>ALTERNATIVES</u>

- 1. CONTINUE consideration of City Council Committees listed on Exhibit No. 1 to another date.
- 2. TAKE any other action the City Council may deem appropriate.

IV. BACKGROUND

By minute action on April 2, 2013, the City Council took the following actions: 1) repealed the action of the City Council of April 3, 2012, to eliminate all City Council Subcommittees; 2) renamed the City Council Subcommittees to City Council Committees; 3) renamed the Redevelopment Agency Council Committee

to the Economic Development Council Committee; and 4) designated the Mayor to appoint the chairperson of each committee (Exhibit No. 3).

On May 21, 2013, Mayor Dear took the following actions: 1) designated member assignments to the City Council Committees; 2) appointed chairpersons to each City Council Committee; 3) determined the Community/Senior Center Council Committee to be an *ad hoc* committee ending May, 2014; and 4) renamed the Home Depot Center to the StubHub! Center (Exhibit No. 4).

On December 17, 2013, Mayor Dear established an *ad hoc* Council Committee for the Proposals and Recommendation regarding the Request for Qualifications (RFQ) with respect to the Energy Efficiency Program, Solar Photovoltaic Power Generating Systems, and Financing Mechanism and designated Mayor Pro Tem Santarina and Council Member Robles to said committee (Exhibit No. 5).

On February 18, 2014, Mayor Dear determined the Landscape and Monument Council Committee to be an *ad hoc* Council Committee and designated Council Member Davis-Holmes to replace Council Member Robles on the Landscape and Monument Council Committee (Exhibit No. 6). On February 24, 2014, he verbally clarified that Council Member Davis-Holmes would also serve as chairperson.

On May 20, 2014, the City Council unanimously approved the creation of an *ad hoc* committee of the Council in order to advise the City Manager on the selection of the next Assistant City Manager and the appointments of Mayor Pro Tem Santarina and Council Member Davis-Holmes to said advisory committee by Mayor Dear (Exhibit 7).

On June 17, 2014, the City Council unanimously reactivated the ad hoc General Plan Advisory Council Committee as a forum to provide input and direction to the City Manager relative to prioritizing future public works projects as discussed during the budget workshop on June 23, 2014, and unanimously approved the mayoral appointments of Mayor Dear and Mayor Pro Tem Santarina to said committee (Exhibit 8).

On July 1, 2014, the City Council unanimously reactivated the *ad hoc* General Plan Advisory Council Committee as a forum to provide input and direction to the City Council relative to prioritizing future public works projects as discussed during the budget workshop on June 23, 2014 (Exhibit 9).

I. PURPOSE AND SCOPE

To establish operational guidelines and procedures regarding the holding of sub-committee. This policy shall not affect City commissions, committees or boards created by formal Council action or by ordinance and meetings called therefore in compliance with the Brown Act.

II. GENERAL

Sub-Committees Created by City Council Action

- A. <u>Creation of sub-committees</u>. There are two types of City Council sub-committees recognized by the City standing sub-committees and ad hoc sub-committees. No City Council sub-committee may consist of more than two members of the Council, although the Council may designate as members of the sub-committee other elected officials and citizens of Carson. All sub-committee members shall be appointed by the Mayor subject to formal approval by a majority of Councilmembers present and voting at a properly noticed and agendized public meeting.
- <u>Standing sub-committees.</u> A standing sub-committee is one created for an indefinite time period or to address general subjects. Generally, any sub-committee created that does not clearly qualify, as an ad hoc sub-committee will be standing sub-committee.
- C. Ad hoc sub-committee. An ad hoc sub-committee is one created for a limited period to address a specific subject or issue of a temporary nature.
- D. <u>Brown Act.</u> All standing sub-committees and ad hoc sub-committees shall comply with all provisions of the brown act, except that an ad-hoc sub-committee comprised <u>soleiv</u> of two Councilmembers and no other persons are exempted, in accordance with state law.
- E. <u>No exceptions</u>. There are no exceptions to this **SMP**. All bodies created by formal City Council action which include one or more Councilmembers, whether called a committee, taskforce special committee, advisory committee, or any other name, shall be considered either standing sub-committee or ad hoc sub-committee for purposes of this SMP.
- F. Informational advisory or other group, town half style meetings, community meetings, or other collective gatherings are not required to comply with the Brown Act, in accordance with State law
- G. Nothing in this Section should be construed to limit the ability of any member of the Council from calling or attending any meeting(s) with constituents when no City resources are used.



III PROCEDURE

The following applies to sub-committees created by formal action or meetings approved by the Council It does not apply to informational advisory or other group, town hall style meeting, community meeting, or other collective gatherings hed by one or two Council members together

Meetings

- A The meeting dates/times will be organized by the General Manager or senior staff member assigned to the sub-committee.
- B Meeting dates/times will be arranged to accommodate the schedules of the Councilmember(s) appointed to the sub-committee.
- Meeting dates/times and agendas may be scheduled on short notice provided all formal posting and notification requirements of the Brown Act are met, unless the sub-committee is not subject to the Brown Act (see Section II, Brown Act)

Sub-committee Agenda Items

- A Any member of a City Council Sub-committee and/or the City Manager may place items on the agenda for consideration by a City Council Sub-committee.
- B Agenda preparation will be completed by the General Manager or senior staff member assigned to the sub-committee and copies will be distributed to the full Council.

Staff Support to Sub-committees

- A General Managers or senior staff members will be assigned to the various subcommittees according to specific subject matters at the direction of the City Manager
- The meetings of standing sub-committees shall be recorded on tape and germane minutes taken by the General Manager or senior staff member to the sub-committee. Tapes will not be transcribed unless requested by a Councilmember or otherwise necessary for conducting of city business. Councilmember requests for verbatim transcription of items considered by any sub-committee will be requested through an item on the City Council agenda
- C. Approved minutes of standing sub-committees shall be kept on file in the City Clerk's office for five years

Advertisement and promotion of Meetings

If there is any advertisement or promotion of the meeting, including production of flyers, mailers handouts, press releases, emails, etc., staff shall follow SMP 1.56 (Council Communications (FLYERS, HANDOUTS AND OTHER PRINTED MATERIAL) and SMP 1.55 (CITY COUNCIL REQUESTS FOR ISSUANCE OR PRESS RELEASE).

Reports and/or Recommendations to Council/Agency

As soon as practical following each standing sub-committee meeting, the General Manager or senior staff member will complete an agenda disposition, noting any decisions or recommendations, and forward this report to all Councilmembers and others as appropriate. Sub-committee agenda dispositions for each sub-committee held during



the previous two weeks will be placed on the City Council agenda (consent) following each meeting

B If a formal report to the Council/Agency is required, and/or if further action is needed by the Council/Agency, then the General Manager or senior staff member will prepare an appropriate agenda item.

IV. EXCEPTION

There shall be no exceptions to this policy, except through direct instructions of the City Council
