### I. <u>SUMMARY</u>

On May 20, 2014, the City Council (Council) directed staff to update the City's oil code, Municipal Code Section 9148.2, within 90 days or to provide a progress report within that time. Council also requested staff to hold two (2) community workshops to allow City residents to participate in this process. This report serves as staff's progress report on the oil code update.

# IV. BACKGROUND

Per Council's direction, staff and the City Attorney (Staff) initiated a search for qualified firms to update the City's Oil Code. During May and June, Staff prepared the scope of work for the oil code update. In doing so, cities with significant oil operations were contacted, as were planning and environmental firms, to help identify qualified consultants to update the Code as it relates to oil wells. Three consulting firms were identified that were qualified to perform this work. The three firms were:

Dyett & Bhatia could not meet City's accelerated schedule due to previous commitments. After interviewing the remaining two firms, Staff identified MRS as the most qualified to update Carson's oil code (Exhibit No. 1). MRS has initiated the code amendment process as OXY has executed a reimbursement agreement to pay for the cost of the oil code amendment.
