Project Description

The Carson Street Master Plan Implementation Project consists of streetscape improvements of the Carson Street Corridor, a 1.75 mile stretch of roadway between the I-110 and I-405 freeways. Improvements include installation of a recycled water line, extensive colorful, drought-tolerant landscaping in parkways and medians, street furniture (benches, bike racks, and pedestrian lights), public art, entry



monuments, traffic signal modifications, reconfiguration of turn lanes, reconstruction of driveways for ADA compliance, and replacement of median street lights with LED lights. The entrance to City Hall at Carson and Avalon is also being refurbished including the construction of an ADA compliant ramp along with hardscape and landscape improvements.

Project Status

Recycled Water (RW) Line Installation: Negotiations remain ongoing between the City of Carson and West Basin Municipal Water District regarding funding of the recycled water line. In the interim, a temporary potable water service to his line has been installed in coordination with CalWater. Installation/testing/certification of a backflow assembly for this new temporary potable service is expected in early January.

City Hall Improvements: The Contractor completed installation of the new City Hall entrance door and plaza landscaping. The construction fencing has been removed and compacted base material placed below the stairs in advance of the upcoming Carson/Avalon Intersection Project. Authorization to Proceed was provided to the Contractor to commence with shop drawings for the City Hall Founders' Fountain Plaza plaques and etchings. These plaques and etchings are anticipated for installation in February.

Streetscape Improvements: Subsurface slag material was demolished/removed on westbound Carson St. between Main St. and Moneta Ave. Removals of slag material are continuing on westbound Carson St. between Moneta Ave. and Figueroa St. Grading and subsurface improvements are ongoing after the slag has been removed from these areas, followed by construction of new curb/gutter, driveways, curb ramps and sidewalk.





Tasks for the Next 30 Days

RW Line Installation

Install the backflow assembly at the new 4" temporary potable water service at Main St.

Energize the line through the newly constructed temporary potable water service.

City Hall Improvements

Install sealer on the architectural pavers.

Streetscape Improvements

Continue demolition and removal of subsurface slag material on westbound Carson St. between Moneta Ave. and Figueroa St.

Continue installation of subsurface electrical and irrigation improvements on westbound Carson St. between Main St. and Figueroa St.

Continue grading and constructed curb/gutter, driveways, sidewalk and curb ramps on westbound Carson St. between Main St. and Figueroa St.

Continue installation of transit shelters and street furniture.

Continue installation of median street lights with modified foundations (five total) and removal of existing lights.

Continue construction of new electrical service pedestals.

Installation of Avalon Blvd. median irrigation.

Install architectural pavers at the north side corners of the Main St. intersection.









Coordinate with West Basin Municipal Water District regarding funding of the recycled water mainline.

Obtain Building & Safety approval for the monument tower.

Coordination with adjacent future projects at the intersection of Carson St. and Avalon Blvd.

Coordination with LA County Department of Public Health regarding installation and proper identification of both recycled water and domestic irrigation systems.

No Contract Change Orders were executed this month. Contract Change Order #5 has been drafted by the Construction Management Team, and is pending review and execution.

Project Completed Tasks for October

RW Line Installation

Construction of new 4" temporary potable water service by California Water.

City Hall Improvements

Installed hand rails.

Installed entranceway door.

Graded/compacted base below the stairs.

Completed irrigation.

Installed trees/landscaping.

Removed construction fencing.

Streetscape Improvements

Demolished and removed unforeseen subsurface slag material on westbound Carson St. between Main St. and Moneta Ave.

Continue installation of subsurface electrical and irrigation improvements on westbound Carson St. between Via Verde and Main St.

Continue grading and constructed curb/gutter, driveways, sidewalk and curb ramps on westbound Carson St. between Via Verde and Main St.

Continued installation of transit shelters and street furniture.

Continued planting trees in Carson St. medians, sidewalks and new bumped out planter areas.

Continued installation of tree grates and stakes.

Continued installation of architectural pavers on the north side of Carson St. at Via Verde.

Constructed seeded concrete median maintenance strips and placed/graded soil within the medians west and east of the Avalon Blvd intersection.





Project Schedule Update

In addition to changes in the scope of the recycled water line work, the recently encountered subsurface slag material has caused the project's schedule to deviate significantly from both the baseline critical path schedule and subsequent monthly updates. A revised schedule for project completion, incorporating revised phasing of the remaining work and scope modifications/change order work, is expected in early January.

Project Look-Ahead

The temporary potable water service to the 8" recycled water mainline has been established and the line is expected to be energized in early 2017, providing a fully-functional irrigation system in the Carson St medians and south parkways between Main St. and Avalon Blvd.

Grading, hardscape and subsurface irrigation and electrical improvements are ongoing on the north side of Carson St from Main St. to Figueroa St.

City Hall improvements have reached substantial completion. Remaining improvements, including the Founders' Fountain Plaza etchings and plaques, are expected to be completed in March. It is anticipated that the Carson St/Avalon Blvd intersection improvements project, which includes construction of a right hand turn pocket on westbound Carson St in front of City Hall, will begin in early 2017.
