

orty-five years ago, on February 20, 1968, the City of Carson was officially incorporated and adopted the motto "Future Unlimited." Carson was part of a Spanish Land Grant known as Rancho San Pedro that was deeded to Juan Jose Dominguez over 200 years ago. During the incorporation process, the community was named after George Henry Carson, a member of the Dominguez family.

The story of Carson began in 1784 when Juan Jose Dominguez, a retired Spanish soldier, petitioned his former commanding officer, Captain Pedro Fages, for 76,000 acres of a Southern California land. Fages, the appointed Military Governor of Alta, California, honored Dominguez's request.

When Dominguez took possession in 1784, he built his adobe on what is now known as Dominguez Hills near Alameda Street and Del Amo Boulevard. He later handed down his land to his nephew's son, Manuel Dominguez, who assumed management of the land until 1825. Over time, the land was subdivided and several acres were granted to other men.

In 1862, Don Manuel Dominguez left his daily supervision of the ranch to his son-in-law, George Henry Carson, a successful merchant, building contractor and a Los Angeles County Public Administrator.

John Manuel Carson, the third child of George Henry's children, supervised the

farming operations on the 3,000 acres extending from Normandie to Vermont Avenues and from 190th to 228th Streets. Eventually, he took over the management of the Dominguez estate and was also responsible for developing much of the South Bay area.

In recognition of his many contributions to the area, Los Angeles County officials named Carson Street after him and the Pacific Electric Railroad named its local station Carson.

A 10-year movement to incorporate the city finally came to fruition on Election Day of February 1968.



s part of the Master Plan of Bikeways project, the City is organizing a community bicycle event, Tour de Carson, on Saturday, April 13. The event will have a food truck, bike safety sessions, free prizes to promote bicycling, and a bicycle tour to evaluate the proposed bicycle improvements within the Draft Comprehensive Master Plan of Bikeways.

A draft proposal of bicycle infrastructure improvements were reviewed by the public at a "Community Workshop" that was held on January 26, 2013. At the meeting, participants were asked to vote on which proposed segments of the plan should be prioritized within the Draft Comprehensive Master Plan of Bikeways, which will be made available for public review and comments in March/April 2013.

Ray Aldridge, Vice-Chair of the Carson Economic Development Commission and resident of Carson for more than 35 years is really glad that discussions have started in putting bike paths in Carson.

"I'm a proud resident of Carson. I really wish we can do something to put in bike lanes soon. I know it will cost a lot of money and imagination. I'd like to be able to get from point A to point B riding my bike. I hate the idea that if I want to ride my bike, I have to load it on to my car and take it to Long Beach or a surrounding beach city just to have a safe ride," said Aldridge.

Chief of Police for California State University, Dominguez Hills, Carlos Velez, who also oversees the Transportation Services for the campus, enjoyed being able to provide input regarding prioritization of the proposed bike lanes.

"We are interested in making our campus community greener," said Velez. "We are looking at different ways to get people out of their vehicle. We want to see what we can do to encourage and provide our input so we can be a part of the map as a destination," added Velez.

For individuals who could not attend the workshop on January 26, you are encouraged to join the Tour de Carson event on April 13 to give your thoughts on the draft Master Plan. City Council Continue to Fly Carson Flag at Three-Quarters Mast

he City flag was first lowered on November 11, 2005 as the City of Carson paid tribute to war veterans during the annual commemoration of Veterans Day at the City's Veterans Park. Since then, all City flags in every City facility have been lowered and will all remain in three-quarters position until the troops return from the war in Afghanistan.

In the January 15, 2013 Council Meeting, the hoisting of City flag at threequarters mast was again unanimously approved by the Council in an effort to demonstrate solidarity as a community that stands by its military personnel who are deployed in war nations.

The lowering of a flag is a universal gesture of mourning. In addition to being a symbol of grief for all the lives lost in the line of duty, the three-quarters position is Carson's gesture of support to the men and women who continue to demonstrate their courage and bravery in their duties in the war nations, particularly Afghanistan. It is also a symbol of hope for the families who continue to pray for the safe return of their loved ones.



Truck Routes Eliminated from Parts of Main and Victoria Streets

he City Council has unanimously approved in the Council Meeting on January 15 to amend the Carson Municipal Code to eliminate truck routes on the following streets: Victoria Street between Main Street and Central Avenue and on Main Street between Broadway and Victoria Street.

In addition to the modification of designated truck routes, the term "handicapped parking" will be changed to "disabled person parking" in Section 3253, consistent with the current documentation.

The amended ordinance would also update the list of designated truck routes so that the Carson Municipal section would be consistent with the truck route map that was approved by the City Council in the most recent General Plan update.

To implement the proposed modifications to the designated truck route system, various "Truck Route" signs along Victoria and Main Streets would have to be modified, added, or eliminated to inform motorists which streets are designated as truck routes. Modification is scheduled to start on March 7.

Modification of truck routes is the City Council's response to neighborhood concerns. It is anticipated that increased enforcement and traffic regulations in these streets will alleviate traffic impacts. ■

Carson to host Elections forMayor, 2 Council Seats, and Measure M

he City of Carson will hold a General Municipal Election on March 5 for the Mayoral seat, two city council seats, and Measure M.

Measure M is a measure that would eliminate the direct election of the Mayor by the voters of Carson, and would return to the selection of the Mayor from among the five elected members of the City Council on a rotating basis. The return to a "rotating" Mayor would go into effect in March 2017, if approved by the voters.

Polling locations throughout the city will open at 7 a.m. and close at 8 p.m.

Counting of ballots will be held at the Congresswoman Juanita Millender-McDonald Community Center after the close of polls. Election results will be aired live on Carson's cable channel 35 on Time Warner, channel 99 on AT&T, and streamed live on the Internet at http://ci.carson.ca.us.

The last day to register to vote is Tuesday, February 19. In order to vote on March 5, residents must complete a Voter Registration form. Forms are available in the City Clerk's Office, US Post Office and online at http://lavote.net/Voter/Voter_Registration.cfm. Registered voters will need to



re-register if they have moved to a different address, changed name, or changed political party affiliation.

All mail-in registrations must be received by the Registrar-Recorder/County Clerk or time-stamped by the City Clerk's Office by February 19.
