## RESOLUTION NO. 17-003

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 8, 2016, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Carson, California, on Tuesday, November 8, 2016, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted; the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the conduct of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

**Section 1.** That the whole number of ballots cast in the precincts except vote by mail voter ballots was 26,130. The whole number of vote by mail voter ballots cast in the City was 11,520, making a total of 37,650 ballots cast in the City of Carson.

**Section 3.** That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates and for and against the measures were as listed in Exhibit “B” attached.

**Section 4.** The City Council does declare and determine that:

ALBERT ROBLES was elected as Mayor for the full term ending November, 2020;

JAWANE HILTON was elected as Member of the City Council for the full term ending November, 2020;

CEDRIC L. HICKS, SR. was elected as Member of the City Council for the full term ending November, 2020; and

That as a result of the election, a majority of the voters voting on the measure relating to ADOPTION OF ORDINANCE 16-1598 AN ORDINANCE OF THE CITY OF CARSON, CALIFORNIA, SETTING TERM LIMITS FOR THE ELECTED OFFICIALS IN THE CITY OF CARSON BY ADDING A NEW CHAPTER 12 “TERM LIMITS FOR ELECTED OFFICIALS” TO ARTICLE II OF THE CARSON MUNICIPAL CODE did vote in favor of it, and that the measure was carried, and shall be deemed adopted and ratified.

That as a result of the election, a majority of the voters voting on the measure relating to ADOPTION OF ORDINANCE 16-1599 AN ORDINANCE OF THE CITY OF CARSON, CALIFORNIA APPROVING A TAX ON CANNABIS RELATED BUSINESS ACTIVITIES BY ADDING CHAPTER 13 (CANNABIS TAX) TO ARTICLE VI (TAXES AND LICENSES) OF THE CARSON MUNICIPAL CODE did vote in favor of it, and that the measure was carried, and shall be deemed adopted and ratified.

**Section 5.** The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) the measures voted upon; (4) for what office each person was voted for; (5) the number of votes given at each precinct to each person, and for and against the measures; and (6) the total number of votes given to each person, and for and against the measure.

**Section 6.** That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

**Section 7.** That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
