- 5 General Member: *Must be a resident of or have a place of employment in the City of Carson.*
- 2 CSUDH Representative: *Must be a resident of or have a place of employment in the City of Carson; recommended by the CSUDH President.*
- 1 Youth Member: *Must be a resident of or have a place of employment in the City of Carson; shall be between the ages of 16-23 years old at the time of appointment and shall represent all such ages; shall have maintained at least a 2.0 grade point average in the previous school year, if in school; shall have an expressed interest in civic engagement issues and concerns.*
- 1 Senior Member: *Must be a resident of or have a place of employment in the City of Carson; shall be at least 55 years of age at the time of appointment.*
- 1 Special Needs Advocate Member: *Must be a resident of or have a place of employment in the City of Carson.*
- 1 Disability Advocate Member: *Must be a resident of or have a place of employment in the City of Carson.*
