May 3, 2018 Publish and Post	1 st publication of 1 st public hearing. Once a week for two successive weeks (GC §6066) (with at least five days intervening). Post in 3 public places (GC §34458(b)) 21 days prior to the date of each public hearing. ²
May 10, 2018 Publish	2 nd publication of 1 st public hearing. Once a week for two successive weeks (GC §6066) (with at least five days intervening). Posting requirement already met on May 3, but post a 2 nd time as a courtesy.
May 15, 2018	FYI Only – City Council Regular Meeting
May 29, 2018 [Special Meeting]	1 st public hearing to be held at 12:30 p.m. Public hearing on matter of the proposal of a charter and the content of the proposed charter (GC §34458(b)).
June 5, 2018	FYI Only – City Council Regular Meeting
June 7, 2018 Publish and Post	1 st publication of 2 nd public hearing. Once a week for two successive weeks (GC §6066) (with at least five days intervening). Post in 3 public places (GC §34458(b)) 21 days prior to the date of each public hearing. ³
June 14, 2018 Publish	2 nd publication of 2 nd public hearing. Once a week for two successive weeks (GC §6066) (with at least five days intervening). Posting requirement already met on June 7, but post a 2 nd time as a courtesy.
June 19, 2018	FYI Only – City Council Regular Meeting

¹ Pursuant to GC 34458(b) at least two public hearings are required; however, the City is not limited to two.

² 21 days is technically 5/8/18 but to be consistent with the publication date, post prior to the 21 days.

<p>July 17, 2018</p>	<p>FYI Only – City Council Regular Meeting</p>
<p>July 24, 2018 [21 days after the second public hearing (GC §34458(b))]</p>	<p>First day that the governing body can vote on whether to approve the submission to the voters of the proposal to adopt a charter (GC §34458(b))</p>
<p>August 7, 2018 [Regular Meeting] [E-88]</p>	<p>Last day to call the election proposing charter.</p>
