

NOTICE OF AVAILABILITY AND NOTICE OF PUBLIC HEARING

Draft Consolidated Annual Performance and Evaluation Report (CAPER) for the Community Development Block Grant (CDBG) Program

The City of Carson announces the availability of the Draft Consolidated Annual Performance and Evaluation Report (CAPER). The CAPER explains the City's use of Federal grant funds under the Community Development Block Grant (CDBG) program administered by the U. S. Department of Housing and Urban Development (HUD). The CAPER covers the period from July 1, 2022 through June 30, 2023.

The CAPER outlines progress made in achieving goals established in the 2020-2024 Five-Year Consolidated Plan and Program Year 2022 Annual Action Plan. The draft CAPER will include: 1) information regarding amounts of funds expended on projects and activities; 2) descriptions of households assisted through expenditure of these funds; 3) actions taken to affirmatively further fair housing; and 4) other information relevant to the status of grant-funded projects administered by the City of Carson affecting local housing and community development needs.

The Carson City Council will conduct a public hearing concerning the CAPER during a regular meeting of the City Council. This public hearing will take place as follows:
