



NOTICE OF INTENTION TO ADOPT OR AMEND A CONFLICT-OF-INTEREST CODE

NOTICE IS HEREBY GIVEN that the City of Carson intends to consider adoption or amendment a conflict-of-interest code pursuant to Government Code §§ 87300 and 87306. Pursuant to Government Code § 87302, the code will designate employees who must disclose certain investments, income, interests in real property and business positions, and who must disqualify themselves from making or participating in the making of governmental decisions affecting those interests.

A written comment period has been established commencing on Monday, June 21, 2010 and terminating on Thursday, August 5, 2010. Any interested person may present written comments concerning the proposed code no later than the close of business on Thursday, August 5, 2010 to the City of Carson City Clerk's Office, which is located at 701 East Carson Street, Carson, CA 90745. No public hearing on this matter will be held unless any interested person or his or her representative requests no later than 15 days prior to the close of the written comment period, a public hearing.

The Conflict of Interest Code has been updated to include new positions, delete positions that have been removed and include more current designation categories. Certain positions will have greater disclosure responsibilities in an effort to ensure the City is as transparent as possible in its dealings with the citizens of Carson. The format has also been restructured to make it easier to understand and more concise for filers to determine what, if any, information they have to disclose.
