This serves as the City of Carson's Notice of Completion and Availability of a Draft Environmental Impact Report for the Hydrogen Pipeline Project (proposed project), prepared in accordance with the California Environmental Quality Act (CEQA), CEQA Guidelines, and local implementation procedures.

Name of Project: 23300 S. Alameda St. Hydrogen Pipeline Project

Project Location: 23330 S. Alameda Street; Carson, CA 90810

Lead Agency: City of Carson, Community Development Department, 701 East Carson Street, Carson, California 90745

Project Description: The proposed Project would construct 0.5 miles of new pipeline within the City of Carson and connect this newly constructed segment with 11.5 miles of existing pipeline, which would be repurposed for hydrogen distribution from its existing hydrogen production facilities located in Wilmington and Carson to the Paramount Refinery.

Such Draft Environmental Impact Report is based on the finding that the project's environmental effects may have a significant effect on the environment. 
