

## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION **Carson Trucking Project**

This serves as the City of Carson's Notice of Intent to adopt a Mitigated Negative Declaration for the Carson Trucking Project (proposed project), prepared in accordance with the California Environmental Quality Act (CEQA), CEQA Guidelines, and local implementation procedures.

Name of Project:

Carson Trucking Project

Project Location:

Between East 223rd Street to the north and East 236th Street to the south

Lead Agency:

City of Carson, Community Development Department, 701 East Carson Street,

Project Description: The project would allow for the construction and operation of a trailer truck and truckmounted container storage parking facility which would include four paved parking lot areas to provide temporary parking and storage for trucks and truck-mounted containers. Trucks and trailers would be parked while waiting to be moved to and from the Port of Los Angeles, Port of Long Beach, or other locations. The general maintenance of truck tractors and equipment would not be allowed. Truck spaces total 565 spaces across the four lots.

> The project requires the following discretionary approvals from the City of Carson: (1) Conditional Use Permit because parking facilities are a conditionally permitted use under the Heavy Manufacturing zoning designation; (2) Development Agreement; (3) General Plan Amendment to remove a future bike path through the project site as shown on the Carson Master Plan of Bikeways; and (4) Site Plan and Design

Review.

NOTICE IS HEREBY GIVEN THAT the City of Carson (City) proposes to adopt a Mitigated Negative Declaration for the above-referenced project. Such Mitigated Negative Declaration is based on the finding that, by implementing the identified standard conditions and mitigation measures, the project's potentially significant environmental effects will be reduced to levels that are less than significant. The reasons to support such a finding are documented by an Initial Study prepared by the City.
