A) Design Overlay Review No. 1289-08, Conditional Use Permit No. 708-08, Variance No. 501-08

### Applicant's Request:

The applicant, Harbor Community Church of God, is requesting to construct an 11,516-square-foot two-story church located in the RM-12-D (Residential, Multifamily – 12 units per acre – Design Overlay) zoning district. The subject property is located at 21739 and 21745 Dolores Street.

## <u>Staff Report and Recommendation</u>:

Associate Planner Gonzalez presented staff report and the recommendation to Waive further reading and Adopt Resolution No. \_\_\_, entitled, "A Resolution of the Planning Commission of the city of Carson approving Design Overlay Review No. 1289-08, Conditional Use Permit No. 708-08, and Variance No. 508-08 for the properties located at 21739 and 21745 Dolores Street.

Chairman Faletogo opened the public hearing.

Pastor Bob Oliver, applicant, stated that their food bank program gives away 766 bags a week to people in need of food and highlighted the church's intent to carry on with this program at the new location. He noted his concurrence with the conditions of approval. He added they may set up a pre-school at this location in the future.

Lourdes Giron, resident, stated that their food bank program has become very popular in the community, and she noted her support of the applicant's request.

Dr. Rita Boggs, resident, stated she has seen the people lining up for the food bank program, and noted her support of this request.
