10. PUBLIC HEARING

A) Extension of Time for Modification No. 3 to Special Use Permit No. 106-74

Applicant's Request:

The applicant, Nader Qoborsi, is requesting a one-year time extension for permitting an additional 21 mobile home spaces to an existing 404-unit mobile home park (Colony Cove Mobile Estates) located at 17700 S. Avalon Boulevard.

Staff Report and Recommendation:

Associate Planner Alexander presented staff report and the recommendation to APPROVE Modification No. 3 to Special Use Permit No. 106-74; and WAIVE further reading and ADOPT Resolution No. 16-2571, entitled, "A Resolution of the Planning Commission of the city of Carson granting a one-year Extension of Time for Modification No. 3 to Special Use Permit No. 106-74 allowing the addition of 16 mobilehome spaces to an existing 404-unit mobilehome park located at 17700 South Avalon Boulevard, Assessor Parcel No. 7319-017-086."

Senior Planner Naaseh explained that this will be the last extension provided, believing the applicant has had adequate time to make a decision on this proposal and that the resolution should so reflect this is the last extension.

Chairman Diaz opened the public hearing.

Tina Tighe, resident in Space 105, stated that she lives next to the oil well and that she has seen no progress in the past two years to cap this well.

There being no further input, Chairman Diaz closed the public hearing.

B) Modification No. 1 to Design Overlay Review No. 468-89

Applicant's Request:

The applicant, McKently Malak Architects, Inc., is requesting a proposed façade remodel of an existing commercial center, reconfiguration of the parking lot, and addition of landscaping located on a property in the MU-CS (Mixed-Use - Carson Street) zone for the property located at 100-180 W. Carson Street.

Staff Report and Recommendation:

Assistant Planner Castillo presented staff report and the recommendation to APPROVE Modification No. 1 to Design Overlay Review No. 468-89; and WAIVE further reading and ADOPT Resolution No. 16-2572, entitled, "A Resolution of the Planning Commission of the city of Carson approving Modification No. 1 to Design Overlay Review No. 468-89 for a proposed façade remodel of an existing commercial center. reconfiguration of the parking lot, and addition of landscaping at 100-180 West Carson Street."

Chairman Diaz opened the public hearing.

Hany Malak, representing the applicant, stated that this project will take approximately four to five months to complete.
