1. CALL TO ORDER

5. PUBLIC HEARING

A) Site Plan and Design Review (DOR) No. 1918-22

Applicant’s request:

Consider finding a CEQA exemption and approval of Site Plan and Design Review No. 1918-22 for a proposed addition to a single-family residence on a 40-foot-wide lot.

Staff recommendation:

Associate Planner Max Castillo presented the staff report and the recommendation to ADOPT Resolution No. 23-2855, entitled, “A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF CARSON FINDING A CEQA EXEMPTION AND APPROVING SITE PLAN AND DESIGN REVIEW NO. 1918-22 FOR A PROPOSED ADDITION TO SINGLE FAMILY DWELLING ON A 40-FOOT-WIDE LOT AT 20912 MARGARET STREET.”

Interim Chair Thomas opened the public hearing.

There being no input, Interim Chair Thomas closed the public hearing.

Planning Commission Decision:

Interim Vice Chair Diaz moved, seconded by Commissioner Hernandez, to approve staff’s recommendation, thus adopting Resolution 23-2855. Motion carried, 6-0.

Interim Vice Chair Diaz – There's always miscommunication, I think it's important to have an interpreter on June 13th.


