#### 4. NEW BUSINESS DISCUSSION

Assistant City Attorney Jones – A public oral communication period needs to be added to the agenda for nonpublic hearing items.

#### Planning Commission Decision:

Interim Vice Chair Diaz moved, seconded by Commissioner Guerra, to add a public communication period. Motion carried, 5-0 (Commissioner Mfume and Commissioner Monteclaro were not present).

#### A) Zone Code Update

Planning Manager Palmer - City Council adopted the General Plan and the Housing Element and with that there are programs that must be done. Updating the comprehensive zoning of the Municipal Code is one of them. There will be a workshop on the next Planning Commission meeting scheduled for July 25<sup>th</sup>. I will be presenting the new Municipal code broken down into parts for discussion. This discussion will help lead the next discussion when the Ordinance is introduced to the Planning Commission in August.

#### 5. PUBLIC HEARING

#### A) Site Plan Design Overlay Review (DOR) No. 1936-23

#### Applicant's Request:

Consider finding a CEQA exemption and approval of Site Plan and Design Review No. 1936-23 for a new addition to a single-family residence on a 40-foot-wide lot.

#### Staff Report and Recommendation:

Assistant Planner Collins presented the staff report and the recommendation to ADOPT Resolution No. 23-2857, entitled, "A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF CARSON FINDING A CEQA EXEMPTION AND APPROVING SITE PLAN AND DESIGN REVIEW NO. 1936-23 FOR A PROPOSED ADDITION TO SINGLE FAMILY DWELLING ON A 40-FOOT-WIDE LOT AT 21114 MARTIN STREET."

Commissioner Guerra - Are there any specific plans as it relates to developing the industrial vacant lot west of the west curve line of the project approved on Martin Street?

Planning Manager Palmer - I will check for any pending entitlements and will send you the information.

Interim Chair Thomas – There is a job fair sponsored by the mayor taking place on Saturday, July 15<sup>th</sup> at the Community Center from 9:00 a.m. to 1:00 p.m. I apologize for the short notice invitation to the presentation of a grant given to the L.A. Sanitation Department for about 1.5 million to help with the brown field that they are looking to remediate and put into use. There was a second invitation for an 80 million grant that is going to be given to the Pure Water Project and I hope all commissioners can

attend if available. It's critical in California not only to reclaim water but make it drinkable again. I would like for staff to present a video with some of the projects that have been approved over the past couple years for everyone to see what has been accomplished and to present to the City Council.

Commissioner Mfume – Are there any plans for repaving 213<sup>th</sup> street and Avalon.

Planning Manager Palmer - I will follow up with public works.
