I. <u>Introduction</u>

The applicant is requesting a one-year time extension for Design Overlay Review (DOR) No. 995-07. The property is located at 23007 Delford Avenue and is in the RS (Residential, Single-family) zone district.

II. <u>Background</u>

On May 22, 2007, the Planning Commission approved Design Overlay Review No. 995-07 authorizing a two-story, 2,130-square-foot single-family dwelling on a 39-foot wide lot. An appeal of Planning Commission Resolution No. 07-2140 was filed on June 4, 2007. At their July 17, 2007 public hearing, City Council affirmed the decision of the Planning Commission by denying the appeal request.

III. Analysis

This extension of time request is to preserve the entitlement granted by the previously approved DOR permit. The applicant has cited a soft housing market and increased difficulty in securing construction loans as primary reasons for not developing the property at this time.

IV. Conclusion

It is recommended that the Planning Commission approve the extension of time for DOR No. 995-07 for one year until July 17, 2009.

V. Recommendation

That the Planning Commission:

- APPROVE the extension of time for DOR No. 995-07 until July 17, 2009; and
- ADOPT a minute resolution extending the approval of DOR No. 995-07 to July 17, 2009.
