I. Introduction

Applicant and Property Owners

Project Description

- To construct a new 863-square-foot, two-story addition to an existing single-family home on a 49-foot wide lot in the RS (Residential, Single-family) zone.
- Site Plan and Design Review is required because the property is 49 feet wide, which is less than the minimum lot width of 50 feet, and the proposal is valued at \$50,000 or more.

II. Background

Previous Uses of Property

The subject property has been in continuous single-family residential use since the construction of the single-family home in 1947.

Previously Approved Discretionary Permits

None

Public Safety Issues

There are no past or current zoning code enforcement cases associated with this property.

III. Analysis

Location/Site Characteristics/Existing Development

- The subject property is located at 21217 Bolsa Avenue between 212th Street to the north and Clarion Drive to the south.
- The subject property is surrounded by RS-zoned properties.
- The subject property is 49 feet wide and 110 feet deep, comprising a total area of 5,486 square feet.
- There is currently a one-story, 1,881-square-foot, three-bedroom, single-family home on the subject property built in 1947.

Zoning/General Plan/Redevelopment Area Designation

- The subject property is zoned RS (Residential, Single-family) with the adjacent properties to the north, south, west and east across Bolsa Avenue sharing the same zoning designation.
- The zoning designation for the subject property is consistent with the General Plan Land Use designation of Low Density Residential.

Project Details

- Once complete, the resulting two-story, single-family home will have six bedrooms, three bathrooms, kitchen/dining room, family room, living room, porch and attached two-car garage for a total of 2,146 square feet.
- The new addition will consist of a stucco exterior and will be painted to match the existing home.



A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF CARSON APPROVING DESIGN OVERLAY REVIEW NO. 1284-08 FOR AN ADDITION TO AN EXISTING SINGLE-FAMILY HOME ON A 49-FOOT WIDE LOT LOCATED AT 21217 BOLSA AVENUE

THE PLANNING COMMISSION OF THE CITY OF CARSON, CALIFORNIA, HEREBY FINDS, RESOLVES AND ORDERS AS FOLLOWS:

<u>Section 1</u>. An application was duly filed by the applicant, Eulogio & Collen Tablan, with respect to real property located at 21217 Bolsa Avenue, and described in Exhibit "A" attached hereto, requesting the approval to construct a new 863 square-foot, two-story addition to an existing single-family home on a 49-foot wide lot in the RS (Residentiai, Single-family) zone

<u>Section 2</u>. A public hearing was duly held on November 25, 2008, at 6:30 P.M. at City Hall, Council Chambers, 701 East Carson Street, Carson, California. A notice of time, place and purpose of the aforesaid meeting was duly given. Evidence, both written and oral, was duly presented to and considered by the Planning Commission at the aforesaid meeting.

Section 3. The Planning Commission finds that:

- a) The proposed project is identified in the General Plan as a permitted use for this land use category and adheres to the goals and objectives of the Housing Element of the General Plan by improving housing stock in the community and enhancing neighborhood quality. There is no specific plan for this area. The surrounding properties are developed with one- and two-story single-family dwellings and the proposed project is compatible with the neighborhood.
- b) The project is compatible in architecture and design with existing and anticipated development in the vicinity, including the aspects of site planning, land coverage, landscaping, appearance and scale of structures and open spaces and other features relative to a harmonious and attractive development of the area.
- c) There are no signs intended for the proposed project except for address identification.
- d) The proposed project conforms to any applicable design standards and guidelines that have been adopted pursuant to Section 9172.15 of the Carson Municipal Code.
- e) The proposed single family dwelling meets the goals and objectives of the General Plan and is consistent with applicable zoning and design regulations. All of the required findings pursuant to Section 9172.23(d), "Site Plan and Design Review, Approval Authority and Findings and Decision" can be made in the affirmative.

<u>Section 4</u>. The Planning Commission further finds that the use permitted by the proposed Design Overlay Review will not have a significant effect on the environment. The proposed use will not alter the predominantly residential character of the surrounding area and meets or exceeds all City standards for protection of the environment. Therefore the proposed project is found to be categorically exempt under the CEQA Guidelines, Section 15301(e).

<u>Section 5</u>. Based on the aforementioned findings, the Commission hereby grants Design Overlay Review No. 1284-08 with respect to the property described in Section 1 hereof, subject to the conditions set forth in Exhibit "B" attached hereto, and approves the categorical exemption.

<u>Section 6</u>. The Secretary shall certify to the adoption of the Resolution and shall transmit copies of the same to the applicant.

Section 7. This action shall become final and effective fifteen days after the adoption of this Resolution unless within such time an appeal is filed with the City Clerk in accordance with the provisions of the Carson Zoning Ordinance.

CONDITIONS OF APPROVAL

DESIGN OVERLAY REVIEW NO. 1284-08

GENERAL CONDITIONS

- 1. If a building permit is not issued within one year of the date of approval of Design Overlay Review No. 1284-08, said permit shall be declared null and void unless an extension of time is requested prior to expiration and approved by the Planning Commission.
- The approved Resolution, including the Conditions of Approval contained herein, and signed Affidavit of Acceptance, shall be copied in their entirety and placed directly onto a separate plan sheet behind the cover sheet of the development plans prior to Building and Safety plan check submittal. Said copies shall be included in all development plan submittals, including any revisions and the final working drawings.
- 3. The applicant shall comply with all city, county, state and federal regulations applicable to this project.
- 4. The applicant shall make any necessary site plan and design revisions to the site plan and elevations approved by the Planning Commission in order to comply with all the conditions of approval and applicable Zoning Ordinance provisions. Substantial revisions will require review and approval by the Planning Commission.
- 5. The applicant shall submit two complete sets of plans that conform to all the Conditions of Approval to be reviewed and approved by the Planning Division prior to the issuance of a building permit.
- 6. The applicant and property owner shall sign an Affidavit of Acceptance form and submit the document to the Planning Division within 30 days of receipt of the Planning Commission Resolution.
- 7. It is further made a condition of this approval that if any condition is violated or if any law, statute ordinance is violated, this permit may be revoked by the Planning Commission or City Council, as may be applicable; provided the applicant has been given written notice to cease such violation and has failed to do so for a period of thirty days.
- 8. All buildings, grounds, parking areas and landscaping shall be maintained in a neat and orderly manner at all times.

- 9. Decision of the Planning Commission shall become effective and final 15 days after the date of its action unless an appeal is filed in accordance with Section 9173.4 of the Zoning Ordinance.
- 10. A modification of the conditions of this permit, including additions or deletions, may be considered upon filing of an application by the owner of the subject property or his/her authorized representative in accordance with Section 9173.1 of the Zoning Ordinance.
- 11. The Applicant shall defend, indemnify and hold harmless the City of Carson, its agents, officers, or employees from any claims, damages, action, or proceeding against the City or its agents, officers, or employees to attack, set aside, void or annul, and approval of the City, its advisory agencies, appeal boards, or legislative body concerning Design Overlay Review No. 1284-08 and all related modifications. The City will promptly notify the Applicant of any such claim, action, or proceeding against the City and the Applicant will either undertake defense of the matter and pay the City's associated legal costs or will advance funds to pay for defense of the matter by the City Attorney. The City will cooperate fully in the defense. Notwithstanding the foregoing, the City retains the right to settle or abandon the matter without the Applicant's consent but should it do so, the City shall waive the indemnification herein, except, the City's decision to settle or abandon a matter following an adverse judgment or failure to appeal, shall not cause a waiver of the indemnification rights herein.

PARKING

- 12. All parking areas and driveways shall remain clear. No encroachment into parking areas and/or driveways shall be permitted.
- 13. Existing driveways in the public right of way shall comply with the ADA requirements to the satisfaction of the City Engineer.
- 14. All areas used for the movement parking, loading, repair or storage of vehicles shall be paved with either:
 - a. Concrete or asphaltic concrete to a minimum thickness of three and onehalf inches over four inches of crushed aggregate base; or
 - b. Other surfacing material which, in the opinion of the Director of Engineering Services, provides equivalent life, service and appearance.

AESTHETICS

15. The specification of all colors and materials and texture treatment must be submitted and approved by the Planning Division prior to the issuance of any building permits.



LIGHTING

- 16. All exterior lighting shall be provided in compliance with the standards as provided for in Section 9127.1 (residential zones) of the Zoning Ordinance.
- 17. All lighting shall be directed away from all adjoining and nearby residential properties.

FIRE DEPARTMENT - COUNTY OF LOS ANGELES

- 18. Fire Department access shall be extended to within 150 feet distance of any portion of structure to be built.
- 19. All required fire hydrants shall be installed, tested and accepted prior to construction. Vehicular access must be provided and maintained serviceable throughout construction.

PUBLIC SAFETY - CITY OF CARSON

20. Ensure compliance with current seismic mitigation codes.

ENGINEERING SERVICES DEPARTMENT - CITY OF CARSON

- 21. A construction permit is required for any work to be done in the public right-of-way.
- 22. Any improvements damaged during the construction shall be removed and reconstructed per City of Carson Standard plan and to the satisfaction of the City Engineer.

BUSINESS LICENSE DEPARTMENT - CITY OF CARSON

23. Per section 6310 of the Carson Municipal Code, all parties involved in the project, including but not limited to contractors and subcontractors, will need to obtain a City Business License.
