I. Introduction

II. Project Description

Don Wilson Builders, represented by Richard Welter, requests approval of DOR No. 1773-19, LLA/COC No. 286-19, CUP No. 1094-19, TTM No. 067200; and recommendation of approval to the City Council for ZCC No. 180-19 and certification of Mitigation Negative Declaration to develop a new 35-unit condominium development.

Carson Municipal Code Section 9172.23 (Site Plan and Design Review) requires Planning Commission review of projects within the Design Overlay District having construction valuation of \$50,000 or more.

Carson Municipal Code Section 9302 (Zoning and Conditional Use Permits Required) states residential condominiums require a conditional use permit.

Carson Municipal Code Section 9172.21 (Conditional Use Permit) states that the Commission shall approve a CUP if it is able to make affirmative findings based on General Plan consistency, the site can accommodate the proposed use, adequate circulation, adequate water supply, compatible with character of the area and such other criteria as are specified for condominiums in the Zoning Chapter of the Municipal Code.

Carson Municipal Code Section 9172.13 (Zone Change) requires that the Planning Commission shall, by resolution, render its decision in the form of a written recommendation to the Council, and such recommendation shall include the reasons for the recommendation, shall specify the relationship of the proposed ordinance to applicable general and specific plans, and shall be transmitted to the Council.

Carson Municipal Code Section 9203.1 (Tentative Maps) requires the tentative map be processed and approved in accordance with the terms and provisions of the Subdivision Map Act and with the provisions of the Zoning Chapter of the Municipal Code.

The proposed condominium development includes the demolition and removal of 15 existing detached single-family homes. It also includes the acquisition of a portion of adjoining parcels 10 (345 E. 220th Street) and 11 (349 E. 220th Street). Once all parcels are combined, the project site will measure approximately 3.11 acres. The proposed condominium development will consist of 35, two-story, free-standing residential units with three and four-bedroom floor plans that will measure approximately 1,844 square feet to 2,138 square feet. The development will include enclosed parking for all residential units, guest parking, open space and internal private road.

III. Project Site and Surrounding Land Uses

The subject property is located in the RM-8-D (Residential Multiple Family-8 dwelling units/acre – Design Overlay) and RM-12-D (Residential Multiple Family-12 dwelling units/acre – Design Overlay) zones and is designated Medium Density Residential under the Land Use Element of the General Plan. The subject property is located on the northeast corner of Dolores Street and 220th Street.

Land uses surrounding the project site include residential, commercial, public/institutional, and utility (So Cal Edison Electrical Substation) uses. The northern boundary of the project site abuts the backside of single-family residential units fronting East 219th Street. The southern boundary of the project site fronts East 220th, and further south are other single-family residential uses and a church. The eastern and western boundaries are adjoined to single-family residential uses.

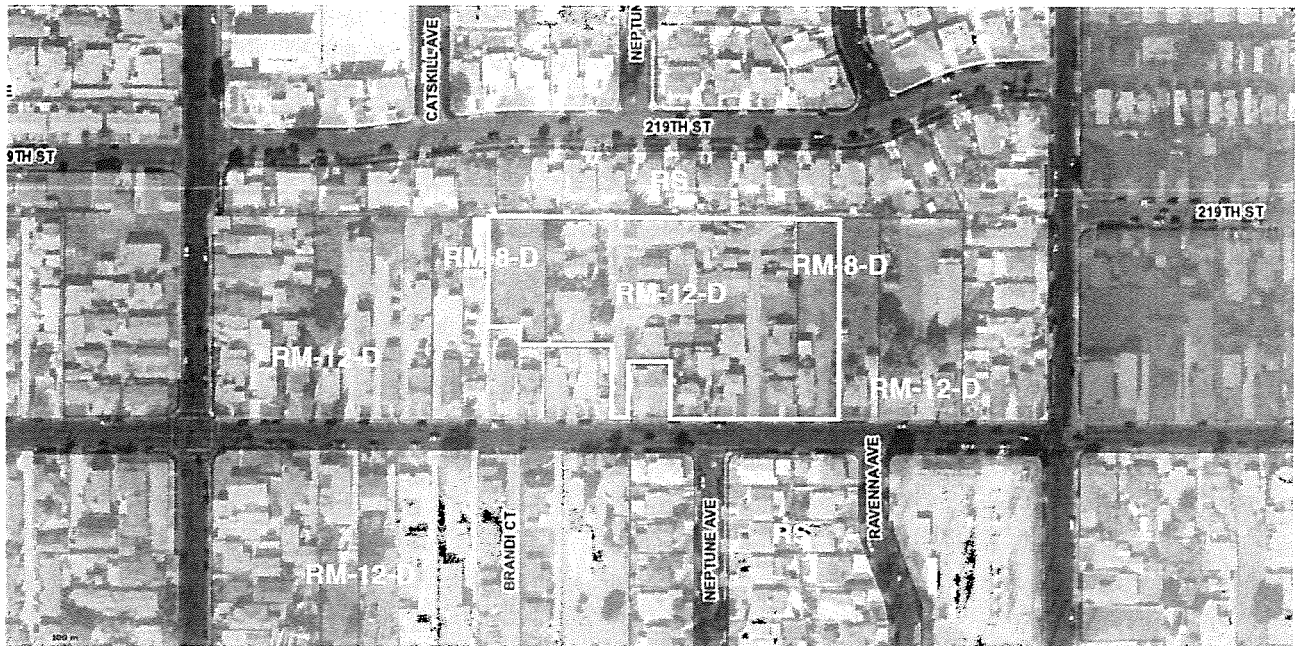


Figure above shows project site in context to its surrounding zoning.

IV. Analysis

Site History

The project area consists of primarily single-family and multi-family residential properties. The majority are designed in a ranch architectural style and built between the 1920's and the 1960's. The First Christian Church of Carson is located immediately south of the subject property and building records indicate it was permitted in 1945.



Site Plan

The 3.11 acre project site will consist of a 35-unit condominium development resulting in a project density of 11.3 units per acre. The project includes 54,000 square feet of usable open space, including 14,000 square feet of private open space (patios and balconies), and 5,100 square feet of common open space, to include a shaded play area, outdoor dining seating area, fire pit, dog run and an outdoor kitchen with built-in BBQ, sink and counter space.

Access

The development will have pedestrian and vehicular accessibility via one entry point located at East 220th Street. The internal driveway will provide full access to the development.

Parking & Traffic

Carson Municipal Code Section 9162.21(Parking Spaces Required) (A. Residential) (4. Condominiums) requires 2 spaces within a garage for each dwelling unit and 1 guest parking space for every 1 multifamily unit with 3 bedrooms or more. The proposed condominium development requires 70 spaces within a garage (2 spaces X 35 units = 70). The proposed development requires 35 guest parking spaces (1 space X 35 units = 35). The applicant proposes 70 spaces within a two-car garage per unit and 35 guest parking spaces; 22 regular, 11 compact and 2 ADA compliant parking spaces.

Building and Architecture

The project architecture is reflective of a three different styles; "Craftsman", Farmhouse" and "Spanish." The proposed building has a maximum height of 30 feet. The building exterior includes vertical and horizontal elements that break up the overall massing and provide visual interest. The exterior building colors will include a variety of neutral earth tones (beige, brown, white, taupe, and gray), while the exterior building materials will include composite shingle roof material, stucco, sectional garage doors, light fixtures, and fiber cement trims and siding. Additionally, some units will include a stone veneer, and others will use decorative bracket siding (Exhibit 2).

Fence and Security

A 6 foot high split-face block wall, with flat precision cap will be installed at the northern, eastern and western property lines, and a majority of the southern perimeter. The wall will include 6 foot 6 inch high split-face block pilasters, with 18 inch square precast cap. The four units facing 220th Street will be secured by a 3 foot 6 inch high CMU garden wall with stucco with precast caps and pedestrian gates. All units will have access to private yards separated by 5 foot 6 inch high vinyl fencing with access gates.

Private Open Space

Carson Municipal Code Section 9128.15 (Development Standards) states that all projects with five (5) units or more shall have an appurtenant private patio, deck, balcony, atrium, or solarium with a minimum area of one hundred fifty (150) square feet. The applicant has designed each unit with a balcony and/or patio measuring approximately 227 to 701 square feet.

Landscaping Requirements

Carson Municipal Code Section 9128.15 (Development Standards) requires that One (1) specimen-size tree (30' inch box tree) shall be provided for each unit. Specimen trees existing on a site prior to development shall be identified on the proposed site plan and shall not be removed without prior written approval from the Director of Community Development. Existing specimen trees may be used to satisfy the landscaping requirement.

The proposed xeriscape landscape plan will comply with applicable water conservation requirements. Permanent irrigation utilizing best water conversation practices will be installed for both on and off site landscaped areas. It will include several tree species across the project site including Olive, Magnolia, California Sycamore, Desert Willow, Italian Cypress and Australian Willow. Trees will be installed to provide screening along all the 220th Street property lines. Additional trees, shrubs and groundcover will be planted to screen the adjoining single-story residences to the north, east and west.

Recreational Facilities

Carson Municipal Code Section 9128.15 (Development Standards) requires all projects one-half acre or larger to include a children's playground calculated at 140 square feet for every three bedroom or more unit in the project. The proposed development requires a minimum 4,900 square foot playground (140sf X 35 = 4,900sf). The applicant proposes 5,100 square feet of common open space, to include a playground with a shade structure, fire place with seating, turf game court, a built-in BBQ/sink and counter for small social events and group gatherings, and a dog run area.

Tentative Map

Tentative Tract Map No. 067200 was reviewed by City of Carson and LA County Department of Public Works who have confirmed that the proposed Tentative Tract Map meets the requirements of local ordinances and the State Subdivision Map Act and have provided conditions of approval for the final map.

V. CFD/DIF Discussion

The proposed development is required to mitigate its impacts on city services. City adopted Community Facilities District (CFD No. 2018-01) and may adopt a similar community facilities district in the future to use instead of CFD No. 2018-01 (collectively referred to herein as the “CFD”) to fund the ongoing costs of law enforcement, street and sidewalk maintenance, landscape maintenance, street sweeping and sidewalk cleaning, and other eligible impacts of the Project within the CFD (the CFD Services). A uniformed-standardized rate was adopted pursuant to Resolution No. 19-009 (“Resolution”) and accompanying Fiscal Impact Analysis (“FIA”) report.

The applicant, property owner, and/or successor to whom these project entitlements are assigned (“Developer”) shall be responsible to establish a funding mechanism to provide an ongoing source of funds for the ongoing services comparable to the uniformed-standardized rate established in the Resolution and FIA report. Based on the adopted Resolution, the subject property falls under “Residential – All Others” rate at \$879.10 per unit per year through June 30, 2020. Based on a 35 unit development, the current estimated annual amount for ongoing services is \$30,768.50, subject to annual adjustments.

Interim Development Impact Fee

The applicant shall be responsible for payment of a one-time development impact fee at the rate of \$14,000 per residential unit constructed and a credit of \$12,500 for every residential unit demolished from the project site.

The proposed development includes development impact fees of \$490,000 (35 new units X \$14,000 = \$490,000). The proposed development includes a credit of \$187,000 (15 units removed X \$12,500 = \$187,000). The applicant will be responsible for development impact fees of \$302,000 (\$490,000-\$187,500 = \$302,500). If the Project increases or decreases in size, the IDIF Amount will be adjusted accordingly at the same rate.

VI. Zoning and General Plan Consistency

Rezone – Zone Change No. 178-17

Current

The site is zoned RM-8-D (Residential Multiple Family-8 dwelling units/acre – Design Overlay) and RM-12-D (Residential Multiple Family-12 dwelling units/acre – Design Overlay).

Proposed

In order to facilitate development of the project, applicant has requested a zone change for all parcels zoned RM-8-D to convert those to RM-12-D thereby creating a contiguous RM-12-D zoned site.

VII. Environmental Review

Pursuant to the California Environmental Quality Act (CEQA), a Draft Negative Declaration was prepared and made available for public review from September 25, 2019 through October 14, 2019. A Notice of Intent to Adopt a Draft Negative Declaration was posted with the City Clerk, LA County Clerk, Carson Library, on-site, and sent to responsible agencies. An electronic copy of the document was also posted on the Planning Division website (<http://ci.carson.ca.us/CommunityDevelopment/Cambria.aspx>). No comments were received recommending that an Environmental Impact Report (EIR) should be prepared.

Potentially significant impacts of Cultural Resources, Geology and Soils, Noise, and Tribal Cultural Resources were identified during the Initial Study. Per the Negative Declaration, with the inclusion of the proposed mitigation measures, adverse impacts are mitigated to the maximum extent feasible and below a level of significance.

VIII. Public Notice

Notice of public hearing was posted at the project site, the local newspaper, Our Weekly, and mailed to property owners and occupants within a 750' radius on January 9, 2020. The agenda was posted at City Hall 72 hours prior to the Planning Commission meeting.

On November, 2019, the applicant went door to door and informed surrounding residents of the proposed project, shared the site plan and renderings and listened to their concerns. The applicant collected 45 postcards in support of the project (Attachment 5).

On January 5, 2020, the applicant again went door to door and presented the site plan, location map, renderings, and elevations to existing tenants of the subject properties.

On January 6, 2020, the applicant hosted a community meeting at the Carson Event Center wherein six residents/tenants attended. Attendees inquired about the timing of the development. No one spoke in opposition.

IX. Recommendation

That the Planning Commission:

- **APPROVE** Site Plan and Design Overlay Review No. 1773-19, Conditional Use Permit No. 1094-19, Lot Line Adjustment No. 286-19, and Tentative Tract Map No. 067200 subject to the conditions of approval attached as Attachment "B" to the Resolution and contingent upon City Council approval of, Zone Change No. 180-19 and Mitigated Negative Declaration; and
- **RECOMMEND APPROVAL** Zone Change No. 180-19 and Mitigated Negative Declaration and adoption of the Mitigated Negative Declaration for the Project to the City Council; and

- **WAIVE** FURTHER READING AND **ADOPT** RESOLUTION NO. 19-___, ENTITLED "A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF CARSON APPROVING SITE PLAN AND DESIGN OVERLAY REVIEW NO. 1773-19, LOT LINE ADJUSTMENT NO. 286-19, CONDITIONAL USE PERMIT NO. 1094-19, TENTATIVE TRACT MAP NO. 067200 AND RECOMMENDING THAT THE CITY COUNCIL ADOPT ZONE CHANGE NO. 180-19 AND MITIGATED NEGATIVE DECLARATION TO DEVELOP A 35-UNIT RESIDENTIAL CONDOMINIUM PROJECT AT 427 E. 220TH STREET."

WHEREAS, on February 19, 2019 the Department of Community Development received an application from Rich Welter, on behalf of Cambria Court, LLC. for real property located at 427 East 220th Street and described in Exhibit "A" attached hereto, requesting approval of Design Overlay Review No. 1773-19, Lot Line Adjustment No. 286-19, Conditional Use Permit No. 1094-19, and Tentative Tract Map No. 067200 and recommendation of approval to the City Council for Zone Change No. 180-19 and certification of Mitigation Negative Declaration to develop a 35-unit condominium project; and

WHEREAS, studies and investigations were made and a staff report with recommendations was submitted, and the Planning Commission, upon giving the required notice, did on the twenty-eight day of January, 2020, conduct a duly noticed public hearing as required by law to consider said applications. Notice of the hearing was originally posted and mailed to property owners and properties within a 750-foot radius of the project site by January 9, 2020; and

NOW, THEREFORE, THE PLANNING COMMISSION OF THE CITY OF CARSON, CALIFORNIA, HEREBY FINDS, RESOLVES AND ORDERS AS FOLLOW:

SECTION 1. The Planning Commission finds that the foregoing recitals are true and correct, and are incorporated herein by reference.

SECTION 2. The Planning Commission finds as follows:

1. With respect to the **Site Plan and Design Review No. 1773-19** to permit the design for a new 35-unit condominium project:
 - a) The proposed project is consistent with the General Plan of the City of Carson. The project site has a General Plan Land Use Designation of Medium Residential and the proposed condominium project is compatible with the surrounding areas.
 - b) The proposed project is compatible in architecture and design with existing and anticipated development in the vicinity, including the aspects of site planning, land coverage, landscaping, appearance and scale of structures, open spaces, and other features relative to a harmonious and attractive development of the area. The proposed

project consists of developing 35 free standing residential condominiums with enclosed parking, open space, guest parking and internal private road.

- c) The proposed development will have adequate street access for pedestrian and vehicles, and also adequate capacity for parking and traffic. The development will have pedestrian and vehicular accessibility via one entry point located at East 220th Street. The internal driveway will provide full access to the development. Carson Municipal Code Section 9162.21(Parking Spaces Required) (A. Residential) (4. Condominiums) requires 2 spaces within a garage for each dwelling unit and 1 guest parking space for every 1 multifamily unit with 3 bedrooms or more. The proposed condominium development requires 70 spaces within a garage (2 spaces X 35 units = 70). The proposed development requires 35 guest parking spaces (1 space X 35 units = 35). The applicant proposes 70 spaces within a two-car garage per unit and 35 guest parking spaces; 22 regular, 11 compact and 2 ADA compliant parking spaces. The project design will allow for and promote safe and convenient pedestrian and vehicle circulation.
 - d) All signage associated with this project will comply with applicable Carson Municipal Code provisions, and will exhibit attractiveness, effectiveness and restraint in signing graphics and color.
 - e) The proposed xeriscape landscape plan will comply with applicable water conservation requirements. Permanent irrigation utilizing best water conversation practices will be installed for both on and off site landscaped areas. It will include several tree species across the project site including Olive, Magnolia, California Sycamore, Desert Willow, Italian Cypress and Australian Willow. Trees will be installed to provide screening along all the 220th Street property lines. Additional trees, shrubs and groundcover will be planted to screen the adjoining single-story residences to the north, east and west.
2. With respect to **Conditional Use Permit (CUP) No. 1094-19** to permit a 35-unit condominium development:
- a) The proposed project is consistent with the General Plan of the City of Carson. The project site has a General Plan Land Use designation of Medium Density Residential and the proposed 35-unit Condominium development is compatible with the surrounding areas.
 - b) The project site is adequate in size, shape, topography, location, utilities, and other factors to accommodate the proposed use and development of a 35-unit condominium.
 - c) The County Fire Department has reviewed the proposed project and concludes that adequate water supply exists to meet current and anticipated fire suppression needs.
 - f) The proposed 35-unit condominium development will be compatible with the intended character of the area. The proposed project consists of developing 35 free standing residential condominiums with enclosed parking, open space, guest parking and internal private road.
3. With respect to the **Tentative Tract Map (TTM) No. 067200**:
- a) Tentative Tract Map No. 067200 was reviewed by City of Carson and LA County Department of Public Works who have confirmed that the proposed Tentative Tract Map meets the requirements of local ordinances and the State Subdivision Map Act and have provided conditions of approval for the final map. The Commission finds it appropriate to approve the Tentative Tract Map conditioned upon resolution of the outstanding items subject to the holds, as stated in the conditions of approval attached hereto as Exhibit

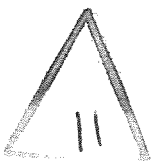
“B,” and to otherwise allow final action thereon to be deferred until the time of consideration of Final Map.

- b) The Tentative Tract Map complies with the City’s Zoning Ordinance and General Plan and is consistent with the intent of Article IX, Chapter 2, Section 9203 (Tentative Maps) of the Carson Municipal Code. The proposed subdivision, together with the provisions for its design and improvement, is consistent and compatible with the General Plan objectives, policies, general land uses, and programs. The proposed project advances the goals and policies related to land use, transportation, housing, and economic development.
- c) None of the findings requiring denial pursuant to California Government Code Section 66474 can be made.
- d) The project site is suitable for proposed 35-unit residential condominium project. The proposed project is an infill project, and all environmental impacts to cultural resources, noise, and tribal cultural resources will be mitigated to existing conditions through the Mitigated Negative Declaration Mitigation Monitoring and Reporting Program (see Section 3, below). The project design of the subdivision will not conflict with any easements on the project site.
- e) There is no basis for the Planning Commission to find that the discharge of waste from the proposed subdivision would result in or add to violation of existing requirements prescribed by a California regional water quality control board, as would provide a basis for disapproval of the Tentative Tract Map pursuant to Government Code Section 66474.6. The Planning Commission’s approval of the project, as conditioned by the conditions of approval attached hereto as Exhibit “B,” requires the applicant to demonstrate that the waste discharge from the proposed subdivision will not result in or add to such a violation in order to obtain a determination of compliance with Section 66474.6 by the City Council at the time of consideration of Final Map approval.

SECTION 3. The Planning Commission further finds that the proposed project, as mitigated pursuant to the Mitigated Negative Declaration and the Mitigation Monitoring and Reporting Program for the Project, which are available for public review at <http://ci.carson.ca.us/CommunityDevelopment/Cambria.aspx> and are incorporated into this Resolution by reference, will not have a significant effect on the environment. A Notice of Determination shall be filed with the County Clerk of the County of Los Angeles pursuant to the California Environmental Quality Act.

SECTION 4. Based on the aforementioned findings, the Commission hereby approves Design Overlay Review (DOR) No. 1773-19, Lot Line Adjustment No. 286-19, Conditional Use Permit No. 1094-19, and Tentative Tract Map (TTM) 067200 and recommends approval to City Council of Zone Change (ZC) No. 180-19, and Mitigated Negative Declaration, subject to the conditions of approval set forth in Exhibit "B" attached hereto and incorporated herein by reference.

SECTION 5. The proposed development is required to mitigate its impacts on city services. A uniform-standardized rate was adopted pursuant to Resolution No. 19-009 (“Resolution”). Based on the adopted Resolution, the subject property falls under “Residential – All Others” rate at \$879.10 per unit per year through June 30, 2020. Based on a 35 unit development, the current estimated annual amount for ongoing services is \$30,768.50, subject to annual adjustments.



The applicant shall be responsible for payment of a one-time development impact fee at the rate of \$14,000 per residential unit constructed and a credit of \$12,500 for every residential unit demolished from the project site. The proposed development includes development impact fees of \$490,000 (35 units X \$14,000 = \$490,000). The proposed development includes a credit of \$187,000 (15 units X \$12,500 = \$187,000). SECTION 6. The Secretary shall certify to the adoption of the Resolution and shall transmit copies of the same to the applicant.

SECTION 7. This action shall become final and effective fifteen days after the adoption of this Resolution and subject to approval of Zone Change (ZC) No. 180-19 and Mitigated Negative Declaration by the City Council unless within such time an appeal is filed with the City Clerk in accordance with the provisions of the Carson Municipal Code.

GENERAL CONDITIONS

1. In accordance to Article XI (Interim Development Impact Fee Program) of the Carson Municipal Code and the current Fiscal Year 2019-2020 fees (effective through June 30, 2020) the applicant shall be responsible for payment of a one-time development impact fee at the rate of \$14,000 per residential unit constructed and a credit of \$12,500 for every residential unit demolished from the project site.

The proposed development includes development impact fees of \$490,000 (35 units X \$14,000 = \$490,000). The proposed development includes a credit of \$187,000 (15 units X \$12,500 = \$187,000). The applicant will be responsible for development impact fees of \$302,000 (\$490,000-\$187,500 = \$302,500). If the Project increases or decreases in size, the development impact fee amount will be adjusted accordingly at the same rate.

Final development impact fee amounts are calculated and due prior to issuance of a building permit in one lump sum installment. Fees are subject to adjustments every July 1 based on State of California Construction Cost Index (Prior March to Current March Adjustment). No building permits shall be issued prior to the full payment of the amount.

2. Funding Mechanism for Ongoing Services / Community Facilities District. The proposed development is required to mitigate its impacts on city services. City adopted Community Facilities District (CFD No. 2018-01) and may adopt a similar community facilities district in the future to use instead of CFD No. 2018-01 (collectively referred to herein as the "CFD") to fund the ongoing costs of law enforcement, street and sidewalk maintenance, landscape maintenance, street sweeping and sidewalk cleaning, and other eligible impacts of the Project within the CFD (the CFD Services). A uniformed-standardized rate was adopted pursuant to Resolution No. 19-009 ("Resolution") and accompanying Fiscal Impact Analysis ("FIA") report.

The applicant, property owner, and/or successor to whom these project entitlements are assigned ("Developer") shall be responsible to establish a funding mechanism to provide an ongoing source of funds for the ongoing services comparable to the uniformed-standardized rate established in the Resolution and FIA report. Based on the adopted Resolution, the subject property falls under "Residential – All Others" rate at \$879.10 per unit per year through June 30, 2020. Based on a 35 unit development, the current estimated annual amount for ongoing services is \$30,768.50, subject to annual adjustments.

Prior to recordation of final tract map or permit issuance, whichever comes first, Developer shall demonstrate compliance under this section either through: 1) Annexing



into a City CFD or 2) Establishing a funding mechanism to provide an ongoing source of funds for ongoing services, acceptable to the City.

3. Development project approval shall become null and void two years following the effective date of application approval unless a building permit is issued and construction is commenced and diligently pursued toward completion or a time extension has been approved by the Planning Manager. This Permit does not supersede an individual time limit for performance of specific conditions or improvements.
4. The approved Conditions of Approval contained herein, and signed Affidavit of Acceptance, shall be copied in their entirety and placed directly onto a separate plan sheet behind the cover sheet of the development plans prior to Building and Safety plan check submittal. Said copies shall be included in all development plan submittals, including any revisions and the final working drawings.
5. The applicant shall submit two complete sets of plans that conform to all the Conditions of Approval to be reviewed and approved by the Planning Division prior to the issuance of a building permit.
 - a. The applicant shall comply with all city, county, state and federal regulations applicable to this project.
6. The applicant shall make any necessary site plan and design revisions to the site plan and elevations approved by the Planning Commission in order to comply with all the conditions of approval and applicable Zoning Ordinance provisions. Substantial revisions will require review and approval by the Planning Division. Any revisions shall be approved by the Planning Division prior to Building and Safety plan check submittal.
7. All construction documentation shall be coordinated for consistency including but not limited to architectural, structural, mechanical, electrical, plumbing, landscape, and irrigation, grading, utility, street lighting, traffic signing, traffic striping and street improvement plans. All such plans shall be consistent with the approved entitlement plans on file with the Planning Department Division.
8. The applicant and property owner shall sign an Affidavit of Acceptance form and submit the document to the Planning Division within 30 days of receipt of approval by the Planning Manager.
9. Decision of the Planning Division shall become effective and final 15 days after the date of its action unless an appeal is filed in accordance with Section 9173.4 of the Zoning Ordinance.
10. A modification of the conditions of this permit, including additions or deletions, may be considered upon filing of an application by the owner of the subject property or his/her authorized representative in accordance with Section 9173.1 of the Zoning Ordinance.
11. It is further made a condition of this approval that if any condition is violated or if any law, statute ordinance is violated, this permit may be revoked by the Planning Division (or Commission), as may be applicable; provided the applicant has been given written notice to cease such violation and has failed to do so for a period of thirty days.
12. Precedence of Conditions. If any of the Conditions of Approval alter a commitment made by the applicant in another document, the conditions enumerated herein shall take precedence unless superseded by a Development Agreement, which shall govern over any conflicting provisions of any other approval.

13. City Approvals. All approvals by City, unless otherwise specified, shall be by the department head of the department requiring the condition. All agreements, covenants, easements, deposits and other documents required herein where City is a party shall be in a form approved by the City Attorney. The Developer shall pay the cost for review and approval of such agreements and deposit necessary funds pursuant to a deposit agreement.
14. Deposit Account. A trust deposit account shall be established for all deposits and fees required in all applicable conditions of approval of the project. The trust deposit shall be maintained with no deficits. The trust deposit shall be governed by a deposit agreement. The trust deposit account shall be maintained separate from other City funds and shall be non-interest bearing. City may make demands for additional deposits to cover all expenses over a period of 60 days, and funds shall be deposited within 10 days of the request therefore, or work may cease on the Project.
15. Indemnification. The applicant, for itself and its successors in interest ("Indemnitors"), agrees to defend, indemnify and hold harmless the City of Carson, its agents, officers, ~~or~~ and employees ("Indemnitees") from and against any and all claims, liabilities, damages, losses, costs, fees, penalties, actions, or proceedings (collectively, "Claims") against Indemnitees to attack, set aside, void or annul any of the project entitlements or approvals that are the subject of these conditions, and any Claims against Indemnitees which are in any way related to any damage or harm to person or property, real or personal, arising from Indemnitors' operations or any of the project entitlements or approvals that are the subject of these conditions. The City will promptly notify Indemnitors of any such claim, action, or proceeding against the City, and Indemnitors will pay the City's associated legal costs and will advance funds assessed by the City to pay for defense of the matter by the City Attorney. The City will cooperate fully in the defense. Notwithstanding the foregoing, the City retains the right to settle or abandon the matter without Indemnitors' consent but should it do so, the City shall waive the indemnification herein, except, the City's decision to settle or abandon a matter following an adverse judgment or failure to appeal, shall not cause a waiver of the indemnification rights herein. Indemnitors shall provide a deposit in the amount of 100% of the City's estimate, in its sole and absolute discretion, of the cost of litigation, including the cost of any award of attorney's fees, and shall make additional deposits as requested by the City to keep the deposit at such level. The City may ask for further security in the form of a deed of trust to land of equivalent value. If Indemnitors fail to provide or maintain the deposit, the City may abandon the action and Indemnitors shall pay all costs resulting therefrom and the City shall have no liability to Indemnitors.
16. After project's entitlement approval, the applicant shall pay all applicable departmental fees. Fees shall be paid at the rate established by resolution of the City Council.

PLANNING DIVISION

17. **Comply with the construction and maintenance with respect to construction and modification of private improvements on 220th Street required to serve the proposed development**
18. **Final Map shall be recorded. Model home building permits may be issued prior to recordation of final map subject to City review and plan check for the model homes. A Certificate of Occupancy will not be released for the model homes until the**

Tentative Tract Map is recorded and temporary exterior improvements are removed.

19. **Model homes cannot be sold, rented, or occupied.**
20. **No other building permits will be issued until the Tentative Tract Map is recorded.**
21. **A bond shall be required to obligate applicant to remove temporary model home exterior improvements such as parking lots, fencing, landscaping, signage, and restrooms.**
22. **Applicant shall submit an administrative plot plan for the approval of model home exterior improvements.**

AESTHETICS

23. There shall be no deviation of architectural design or details from the approved set of plans. Any alteration shall be first approved by the Planning Division.
24. Any roof-mounted equipment shall be screened to the satisfaction of the Planning Division.
25. Prior to Issuance of Building Permit, the specification of all colors and materials must be submitted and approved by the Planning Division.

CONDOMINIUMS

26. The condominium project shall conform to all the development standards as outlined in Section 9305 and 9128.15 of the Zoning Ordinance, unless otherwise provided for in this approval. For purposes of clarity, this approval allows for the requirement of one 30" box specimen tree for each condominium unit; required recreational facilities, including requirement for a clubhouse and children's playground; the amount and configuration of private storage space; interior sound attenuation requirements.
27. The Declaration of Covenants, Conditions, and Restrictions (CC&Rs) shall be provided for as outlined in Section 9307 and 9128.17 of the Zoning Ordinance and submitted to the Planning Division for review and approval. The CC&Rs shall contain statements that the project will be in compliance with city, county, and state regulations. The CC&Rs shall ensure proper maintenance of the common areas by a professional management agency. All Conditions of Approval shall be included within the CC&Rs. No changes to the approved CC&Rs shall be made without the City's consent. The CC&Rs shall be recorded concurrently with the map (townhomes).
28. All ground-mounted equipment including air conditioners and transformers shall be screened from public view.
29. All Conditions of Approval shall be contained within the CC&Rs.
30. The CC&Rs shall include language that prohibits the Homeowner's Association (HOA) from ceasing professional property management without obtaining City of Carson City Council approval.
31. **Carson Municipal Code Section 9128.15 (Development Standards) requires all projects one-half acre or larger to include a children's playground calculated at 140 square feet for every three bedroom or more unit in the project. The proposed development requires a minimum 4,900 square foot playground (140sf X 35 = 4,900sf).**

Prior to occupancy of any unit (except models):

32. The applicant shall provide a final City Attorney approved copy of the CC&Rs to the Planning Division.

ENVIRONMENTAL

33. Prior to issuance of grading permit and building permit, a revised mitigation monitoring program matrix/spreadsheet shall be submitted to the City, as applicable, for review and compliance with the mitigation measures for Cambria Court, LLC Mitigated Negative Declaration dated September 2019
34. Prior to Certificate of Occupancy, the project shall demonstrate compliance with all applicable mitigation measures in the Mitigation Monitoring and Reporting Program for Cambria Court Residential project dated September 2019. A final mitigation monitoring matrix/spreadsheet shall be submitted to the City.

LANDSCAPE/IRRIGATION

35. Comply with the provisions of the Los Angeles County Green Building Code Section "Water Efficient Landscaping."
36. Landscaping shall be provided with a permanently installed, automatic irrigation system and operated by an electrically-timed controller station set for early morning or late evening irrigation.
37. Installation of 6" x 6" concrete curbs are required around all landscaped planter areas, except for areas determined by National Pollutant Discharge Elimination System (NPDES) permit or other applicable condition of approval that requires certain landscaped areas to remain clear of concrete curbs for more efficient storm water runoff flow and percolation. Revised landscaping and irrigation plans shall be reviewed and approved by the Planning Division should subsequent modifications be required by other concerned agencies regarding the removal of concrete curbs.
38. Installation, maintenance, and repair of all landscaping shall be the responsibility of the property owner.
39. The proposed irrigation system shall include best water conservation practices.
40. Incorporate additional landscaping to screen and block specific project areas that could be subject to graffiti as determined by the Planning Division.

LIGHTING

41. All exterior lighting shall be provided in compliance with the standards pursuant to Section 9127.1 (Exterior Lighting) of the Zoning Ordinance.
42. Such lights are to be directed on-site in such a manner as to not create a nuisance or hazard to adjacent street and properties, subject to the approval of the Planning Division.

PARKING

43. Parking areas and driveways shall remain clear. No encroachment into parking areas and/or driveways shall be permitted.

TRASH

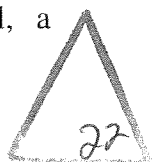
44. Trash collection shall comply with the requirements of the City's trash collection company.
45. Recycling areas shall be provided in accordance with Sections 9164.4 (Collection and Loading of Recyclable Materials) and 9164.5 (Design Standards for Trash and Recycling Areas) of the Zoning Ordinance. The number and size of recycling facilities are specified on the site plan.

UTILITIES

46. All utilities and aboveground equipment shall be constructed and located pursuant to Section 9126.8 (Utilities) of the Zoning Ordinance, unless otherwise provided for in these conditions.
47. Public utility easements shall be provided in the location as required by all utility companies with easements free and clear of obstructions, and electrical utilities shall be installed underground.
48. The applicant shall remove at his/her own expense any obstructions within the utility easements that would interfere with the use for which the easements are intended.
49. Any aboveground utility cabinet or equipment cabinet shall be screened from the public right-of way by a decorative block wall or landscaping, to the satisfaction of the Planning Division, and in compliance with public utility access requirements.

CITY OF CARSON PUBLIC WORKS DEPARTMENT, ENGINEERING SERVICES DIVISION

50. Any existing off-site improvements damaged during the construction shall be removed and reconstructed per City of Carson PW Standard Drawings and to the satisfaction of the City Engineer.
51. A construction permit is required for any work to be done in the public right-of-way.
52. Construction bond for all work to be done within the public right of way shall be submitted and approved by Engineering Division prior to issuance of permit by Engineering Division.
53. Proof of Worker's Compensation and Liability Insurance shall be submitted to the city prior to issuance of permit by Engineering Division.
54. Construction bond for all work to be done within the public right of way shall be submitted and approved by Engineering Division prior to approval of the Final Map.
55. A Final Map prepared by, or under the direction of, a pre-1982 Registered Civil Engineer or Licensed Land Surveyor must be processed through the City Engineer prior to being filed with the County Recorder.
56. CC&R's (covenants, conditions, and restrictions) to address drainage responsibilities are required.
57. Private easement will not be granted or recorded within areas proposed to be granted, dedicated, or offered for dedication until after the Final Map is filed with the County Recorder. If easements are granted after the date of tentative map approval, a



subordination must be executed by the easement holder prior to the filing of the Final Map.

58. Prior to final map approval, quitclaim or relocate any easements interfering with building locations to the satisfaction of the City, appropriate agency or entity.
59. Provide suitable turnaround and label the driveways "Private Driveway and Fire Lane" on the Final Map to the satisfaction of the Fire Department.
60. Prior to tentative map approval, a soils report, sewer area study, drainage concept, hydrology study and stormwater quality plan shall be reviewed and approved. Tentative map approval will not be granted until the required soils, sewer, drainage concept, hydrology study and stormwater information have been received and found satisfactory.
 - a. Comply with mitigation measures recommended in the approved soils, sewer area study, drainage concept, hydrology study and stormwater quality plan.
61. Prior to tentative map approval, The Developer shall submit a sewer area study to the Los Angeles County Department of Public Works (LACDPW) to determine if capacity is adequate in the sewerage system to be used as the outlet for the sewer of this development. If the system is found to have insufficient capacity, the problem must be addressed and resolved to the satisfaction of the L.A. County Sewer Department.
62. The Developer shall install separate sewer laterals to individually serve each building in the development. Installation and dedication of main line sewers may be necessary to meet this requirement.
63. Drainage/Grading plan prepared by a registered Civil Engineer, to the satisfaction City of Carson Department of Public Works.
64. The Developer shall comply with applicable LID requirements (*Carson Municipal Code 5809*) and shall include Best Management Practices necessary to control storm water pollution from construction activities and facility operations to the satisfaction of Building and Safety, LA County DPW and the City.
65. A water system maintained by the water purveyor, with appurtenant facilities to serve all buildings in the development must be provided. The system shall include fire hydrants of the type and location as determined by the Fire Department. The water mains shall be sized to accommodate the total domestic and fire flows.
66. The Developer shall send a print of the development map to the County Sanitation District, to request for annexation. The request for annexation must be approved prior to Final Map approval.
67. A final guarantee will be required at the time of the filing of the Final Map with the County Recorder/County Clerk's Office.

Prior to issuance of **Building Permit**, the proposed development is subject to the following:

68. Final Map shall be recorded.
69. Drainage/Grading plan shall be submitted for approval of the Building and Safety Division. The Developer shall submit a **copy of approved** Drainage/Grading plans on bond paper to the City of Carson – Engineering Division.
70. Prior to issuance of a Building Permit the Developer shall execute and provide to the City Engineer, a written statement from the water purveyor indicating that the water system

will be operated by the purveyor and that under normal conditions, the system will meet the requirements for the development and that water service will be provided to each building.

- a. Comply with mitigation measures recommended by the water purveyor.
71. Additional Right-of-Way is required beyond the existing right-of-way line. Dedicate 5-ft of additional right-of-way abutting the development along 220th street. New Right-of-Way line shall be 30-ft from existing centerline. Developer shall prepare legal description for required dedication, for review and approval of the City Engineer and Recordation with County Recorder's Office. All documents shall be approved and ready for recordation prior to issuance of Building Permits.
72. The Developer shall submit improvement plans to the Engineering Division showing all the required improvements in the public right of way for review and approval of the City Engineer. A copy of approved conditions of approval shall be attached to the plans when submitted.
 - a. Street Improvements along 220th Street abutting project frontage.
 - b. Sewer Main Improvements as determined by the aforementioned sewer area study.
 - c. Storm Drain Improvements (if any) as determined by the aforementioned requirement.
73. Off-site improvements (eg. driveways, sidewalk, parkway drains, trees, curb/gutter etc) shown on the grading plans must provide a concurrent submittal to City of Carson Engineering Division. Off-site improvements may be shown on a separate set of street improvement plans. Prior to issuance of Grading permit, developer shall obtain clearance from City of Carson Engineering Division.
74. The Developer has the option to make a cash payment/ shall make a cash payment to the City of Carson In-Lieu of constructing the following Improvements:
 - a. Streets abutting the development, shall be slurry sealed from curb-to-curb or as approved by the City Engineer. Slurry Seal materials shall be rubberized emulsion aggregate slurry (REAS). Developer may pay a fee in-lieu of application of Slurry Seal. (\$0.45 per square foot \$1,350.00 minimum fee for first location up to 3,000 square feet)

Prior to issuance of Certificate of Occupancy, the proposed development is subject to the following:

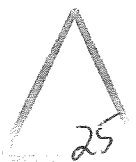
75. The Developer shall comply with all requirements from L.A. County Sewer Maintenance Division for maintenance of new and/or existing sewer main, relating to this development, prior to release of all improvement bonds.
76. The Developer shall construct and guarantee the construction of all required drainage infrastructures in accordance with the requirements and recommendations of the hydrology study, subject to the approval of the City Engineer.
77. Repair any broken or raised/sagged sidewalk, curb and gutter within the public right of way along 220th Street abutting this proposed development per City of Carson PW Standard Drawings and to the satisfaction of the City Engineer.
78. Install sidewalk along 220th Street abutting this proposed development per City of Carson PW Standard Drawing No. 116.



79. Remove and replace any broken/damaged driveway approach within the public right of way along 220th Street abutting this proposed development per City of Carson PW Standard Drawings and to the satisfaction of the City Engineer.
80. Remove unused driveway approach if any, within the public right of way along 220th Street abutting this proposed development and replace it with full height curb and gutter and sidewalk per City of Carson PW Standard Drawings and to the satisfaction of the City Engineer.
81. If required, the Developer shall modify existing driveways within the public right of way along 220th Street abutting this proposed development per City of Carson PW Standard Drawings to comply with the ADA requirements and to the satisfaction of the City Engineer.
82. The developer shall construct new driveway approaches per City of Carson PW Standard Drawings and in compliance with the ADA requirements. The Developer shall protect or relocate any facilities to accommodate the proposed driveway approach. The maximum driveway approach width allowed for the site is 26 feet.
83. Plant parkway grass in the public right of way along 220th street abutting this proposed development to the satisfaction of the City Engineer.
84. Plant approved parkway trees on locations where trees in the public right of way along 220th Street abutting this proposed development are missing per City of Carson PW Standard Drawings Nos. 115, 116, 132, 133 and 134.
85. Install irrigation system for the purpose of maintaining the parkway trees to be planted within the public right of way along 220th Street abutting this proposed development.
86. All new utility lines, servicing the proposed development shall be underground to the satisfaction of the City Engineer.
87. Comply with any additional requirements, if any, as means of mitigating any traffic impacts as identified in the traffic study approved by the City Traffic Engineer.
88. Install striping and pavement legend per City of Carson PW Standard Drawings.

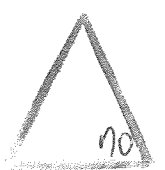
