

## **City of Carson COVID-19 Update**

Monday, October 26, 2020

The coronavirus outbreak began in Wuhan, China, and has since spread across the globe impacting many countries including the United States. The first case of COVID-19 in the United States was reported on January 14, according to the Centers for Disease Control and Prevention (CDC). To help keep the community informed, the City of Carson is providing COVID-19 news updates related to health and safety tips, and informational links to meet the needs of the community and protect public health.

To slow the spread of the coronavirus, public health officials urge residents to practice social distancing, wash their hands regularly, wear a face covering and stay home as much as possible and avoid the "Three C's": Crowded places, Confined Spaces and Close Contact.

- L.A. County Businesses Are Being Encouraged To Take Advantage of The COVID-19 Safety Compliance Certification Program which offers business owners and employees the opportunity to participate in a free training program about COVID-19 infection control protocols so that they can be in compliance with infection control and physical distancing requirements. Businesses have a duty to protect employees and



customers from transmission of COVID- 19 and must implement all requirements in the business protocols for reopening and many businesses have not. - California Blueprint For Reducing COVID-19 Has Been Updated with revised criteria for loosening and tightening restrictions on activities for individual counties which have a tier based designation on its test positivity and adjusted case rate. To advance to the next less restrictive tier, each county will need to meet the California Health Equity Metric which was designed to help guide counties so they will need to meet the metric or demonstrate targeted investments to eliminate disparities in levels of transmission. - Consecutive Minutes Of COVID-19 Exposure Needed To Be A 'Close Contact' have been reduced by the CDC indicating that the definition of a close contact would be as someone who spent at least 15 minutes within 6 feet or for over a 24-hour period of a confirmed case according to the Centers for Disease Control and Prevention definition. - \$81.4 Million Were Released In A Sixth Round Of Homekey Project Awards to 5 applicants for 6 projects totaling 430 units through this nation-leading program which enables the state to purchase and rehabilitate housing including hotels, motels and vacant apartment buildings and convert them to homeless housing to continue the state's collective efforts to reduce the pandemic's impact on the most vulnerable Californians. Funds have been awarded as follows: Los Angeles County \$24.1 million; San Francisco \$29.1 million; Oakland \$17.5 million; Santa Clara County \$9.5 million; San Bernardino County \$1.1 million.
